To receive 5 points you must have served on active duty in the Armed Forces of the United States:

 $\hfill\square$ For at least one day in a combat zone; or

To qualify under any of the above, you must have been discharged or released under honorable conditions.

**Please note: "active duty" does not include attendance at a school under military orders, except schooling incident to an active enlistment or a regular tour of duty, or normal military training as a reserve officer or member of an organized reserve or a National Guard unit.

QUALIFIED DISABLED VETERAN QUESTIONS: You may claim preference as a disabled veteran if you check at least one box below and provide proof of eligibility by submitting a copy of your **DD-214 or 215** (long form / **Member Copy-4**) that reflects your honorable separation status and a public employment preference letter from the Department of Veterans' Affairs (unless the information is already included in the federal DD Form 214/215).
