1 - General Comments

ePermit Training

Florence Building will "go live" with ePermits before Oct. 1, 2011, according to Debbie Wells, the Building Codes Division coordinator for ePermits. There are still issues to be dealt with regarding the customized Florence configuration, but staff has been in intensive training to facilitate joining the statewide ePermits system. There is also a state helpline available for assistance if and when needed to deal with any issues or problems that may arise at implementation of the program, if necessary. Building Official Carl Dependahl, Building Technician Eric Rines, and Assistant Planner Michelle Pezley deserve kudos for the hard work put in to learn the program. And special appreciation is extended to Debbie Wells who has been a patient instructor.

Military Heritage Museum


The Oregon Military Heritage Museum has broken ground for the 5900 square foot facility on Kingwood. Excavation has been done; forms and steel are being installed. The building corners were located and staked by Wobbe and Associates (surveyors) to ensure an accurate location. There were several volunteers onsite alongside Tim Sapp, with the Museum Association. Jerry Prater, the General Contractor and crew were also hard at work. The Airport site is a beehive of activity, with Public Works, Wildish Construction, and Lantz Electric onsite for enlargement of the runway ramp, in addition to the Military Heritage Museum work. 
Staff Stepping Up
