Water, Stormwater, and Roadway Improvement Project

News Rhododendron Drive – 9th to Hwy 101 Kingwood Street – 2nd to Rhododendron Drive

On October 31, Carter & Company Inc. started construction on a \$2.655 million improvement project on Rhododendron Drive. The project will replace the small diameter water lines within Rhododendron Drive between 9th and Kingwood streets with a new 16-inch water main, extend a 12-inch water main on Rhododendron Drive between Kingwood and Hwy 101, and install a 16-inch water main within Kingwood from 2nd to Rhododendron Drive.

Stormwater improvements will consist of replacing an existing culvert crossing of Rhododendron Drive west of the Wastewater Treatment Plant, installing stormwater crossings at key locations on Rhododendron Drive to facilitate future projects, and stormwater improvements along Kingwood Street between 2nd and Rhododendron Drive. The culvert crossing next to the Wastewater Treatment Plant will be completed with the installation of a new 42-inch stormwater pipe and concrete headwalls. Stormwater improvements along Kingwood Street will consist of 18-inch and 15-inch pipes.



Once the water and stormwater facilities have been completed, the contractor will be installing two 6-foot bike lanes along Rhododendron Drive between 9th and Hemlock streets. Additionally, a new 5-foot sidewalk will be constructed along the north and east sides of Rhododendron Drive from 9th Street to Hemlock Street. Both Rhododendron Drive and Kingwood Street will have a new paved surface once the project is completed.

During much of November, the contractor has focused their on clearing and grubbing the vegetation along Rhododendron Drive between 9th and Greenwood streets. The contractor has also cleared and removed a considerable amount of soil just west of Greenwood Street in order to install three retaining walls. The retaining walls are gravity block walls.

During December, the contractor will begin installing the new 16-inch water main on Rhododendron Drive starting at 9th Street and heading east. They will also start installing the new stormwater system on Kingwood between Rhododendron Drive and 2nd Street

Florence Public Works would like to extend our

thanks to the public for their patience as we begin this very important project that will bring improved water supplies for fire suppression to the Hospital and surrounding area. Although we have planned the construction well and have worked hard to minimize any inconvenience, due to the nature of this construction project there will be slight inconveniences, particularly to the residents that live along the route of the construction. The City sincerely apologizes for any inconvenience we or the contractor might cause during this project and we will certainly try to minimize those inconveniences.

The project is scheduled to be completed by the end of March 2017. Please proceed cautiously through the work zones or take alternate routes when necessary.


Economic Development Committee


Florence Urban Renewal Agency (FURA)

The mission of the Urban Renewal Agency is to revitalize the Florence downtown area as the primary cultural, tourist, commercial, and community core to serve all Florence's citizens and visitors, encouraging continuing growth, development, and enhancement consistent with Florence's small-town ambiance and character. The board has 9 members: the Mayor of Florence, two City Councilors, members nominated by the Lane County Board of Commissioners, the Western Lane Ambulance District, and the Port of Siuslaw and/or the Siuslaw Library District. The remaining members are citizens at large. The Florence Police Auxiliary Officers have provided these 10 helpful tips for keeping your home safe during the holiday season.

- I. Keep doors locked at all times. This includes when you are home and even when it's light out.
- 2. Keep the curtains and blinds closed. This will ensure that no one can take a peek at your valuables.
- 3. If away, give your home a "lived-in" look with a device scheduled to turn lights on or off at a specific time.
- 4. Collect packages and deliveries as soon as they arrive, or have a neighbor pick them up for you.
- 5. Collect your newspaper and mail as soon as they arrive.
- 6. Make sure there is no shrubbery crowding entry points of the home that would block visibility.
- 7. If you have a garage, make sure you are packing and unpacking gifts from the car inside of the garage so no one can see what you purchased.
- 8. Don't advertise your Christmas gift purchases on social media, as many thieves use social media to find potential victims.
- 9. Don't advertise your out-of-town holiday plans on social media or post pictures until after you have returned.
- 10. If leaving for the holidays, file a Vacation Patrol Request, found under forms on the City's website, to let the police know you are away and to be added to the list of areas that the Police Auxiliary Officers check on during their patrols. News from the November Council Meetings

At the November 7 City Council meeting, the City Council approved an agreement with Banner Bank for financing and refinancing \$9.8 million in projects. These changes represent a huge savings to the city by reducing the interest rate from 3.25% to 2.92%. Projects intended to be funded include refinancing debt from the

construction of the Siuslaw Library, funding the Florence Urban Renewal Agency project, construction of the new public works facility, and construction of street and water infrastructure projects.

During November we also completed the following:

- > Approval of an engineering contract for water and wastewater improvements along Hwy 126.
- Approval of a contract to begin clearing the lot for the new public works facility.

- Approval of a liquor license for American Market located at 2515 Hwy 101.
- Reports on the next steps with the School Resource Officer grant, City Services billing changes, wastewater industrial users survey, public works facility, financial report, holiday festival and banners, and Boards and Committees.
- > Introductions of Sergeant Brandon Ott and Economic Development Catalyst Jesse Dolin.
- Presentations and Proclamations for Military Family Appreciation Month, the Florence Police Fleet, Siuslaw Region 2025 Vision, Patriotic Employer Award for Commander Pitcher, and Departmental website updates.

Notice of Changes to Utility Billing Policies

This notice is to inform our customers of changes related to past due accounts and our efforts to collect these account balances in a timely and cost-effective manner. The following changes were effective November 28, 2016:

- The City will no longer mail Notices of Discontinuing Water Service.
- The next regular City Services Bill will serve as a shut-off notice and will include the past due amount and the final date to pay to avoid shut-off.
- The City will no longer distribute door hangers prior to the shut-off date.
- The City will mail a final shut-off notice with the intent to give customers at least 48 hours of notice.

Site Clearing for New Public Works Facility

In preparation for construction of the new Public Works Operations Center, the City contracted with Ray Wells, Inc. to complete the clearing and grubbing of the site to help accelerate the building construction process. Crews from Ray Wells, Inc. started to remove the heavy vegetation from the 2.75 acre site (lots 12, 13, and 14) at the southwest corner of Kingwood and 27th Street.

In addition to the vegetation, the contractor's crews will remove the root mat from the site. They will clear the ground of vegetation, including trees, stumps, and brush. All embedded stumps, root mat, etc., will be removed to a depth typically not less than 2 feet below the surface. This is especially important in areas where there will be buildings or paved areas. If the organic material (root mat, stumps, vegetation) is not removed, the material will decompose over time, creating voids under foundations, building slabs, driveways, or parking areas.

The vegetation and trees that are removed from PW Operations Facility. the site will not go to waste. The vegetation material will be mulched using a horizontal grinder. The mulched material will be stock piled at the north end of the Florence Municipal Airport property to be used as feed stock for our biosolids composting program.

Since Florence is known as the City of Rhododendrons, the contractor will attempt to preserve nice specimens of the native rhododendrons from the site so that they can be transplanted to other City property locations. Some of the rhododendrons will be transplanted in Miller Park, while others will be moved to a secure location for transplanting in the future.

The clearing and grubbing of the site should take two weeks to complete. Bids for the construction of the new Public Works facility are due on December 6, 2016.

After review of the construction bids by staff and the architect, a recommendation to award a contract to the successful bidder (contractor) will be made at the December 19, 2016 City Council meeting.

New "Over the Counter" Plan Reviews Now Available for Select Projects



Have you wanted to make some exterior changes to your commercial building without all the regulatory red tape fuss? You're in luck! On November 17, 2016, the NEW "Over the Counter" application process for reviewing and approving plans to modify buildings went into effect. All commercial buildings in all zoning districts and homes within the Old Town and Mainstreet zoning districts can now take advantage of this new process. This action will save property owners as much as 45 days of wait time and \$1,300 in application fees!

This action was the result of a year-long

process where architectural design standards were researched and written and then reviewed by the Florence Planning Commission and City Council during work sessions open to the public. The public then had the opportunity to review and offer their input. Now, because the building design standards are in the code, the new over-the-counter process grants city staff the opportunity to review proposals against the code and approve them without the need for public notice or hearings before the Planning Commission.

Information about the new process is in Florence City Code Title 10 Chapter I and can be viewed here, and the new architectural standards are in Title 10 Chapter 6 and can be viewed here (see footnotes). All commercial and apartment buildings require City review prior to any modifications to the exterior of the structure. improvements such as reroofing, re-siding, replacing or adding doors or windows, and painting or adding exterior features such as awnings. Save yourself some time and money by having your materials and plans reviewed prior to purchase or installation with the city's new overthe-counter review process. Be a Force of Nature: Prepare and Stay Safe! #WinterSafety

On average, weather-related vehicle crashes kill 6,253 people and injure more than 480,000 each year, according to the Department of Transportation. Most of these accidents occur when the roadways are wet, snowy, or icy. When the weather takes a turn for the worse this winter, take precautions if you have to be out on the roadways. Whether

there is a coating of snow or ice on the road, or the asphalt just looks wet, SLOW DOWN! If the temperature is near freezing, drive like you're on ice—you may be!

While dangerous road conditions are one of the most deadly hazards during winter, it's not the only threat you may encounter. Other winter hazards include brutal cold, heavy snow and ice, dangerous flooding, extreme wind, and treacherous fog.

Nobody knows more about these weather hazards than NOAA's National Weather Service. Here is what we recommend you do this winter:



I. Know Your Risk

Check <u>weather.gov</u> every morning before you leave home. It may be sunny in the morning but snowing in the afternoon. Be prepared.

2. Take Action!

Prepare for an emergency. Write a <u>family communications plan</u> so that everyone in your life knows how to stay in touch. Also, assemble an <u>emergency supplies kit</u> for your home. Make sure you have 72 hours of food, water and other necessary supplies in your kit.

During a snow emergency, stay off the roads to allow emergency crews uninterrupted access to treat the roads, and if you must travel, allow extra time. Follow <u>weather.gov</u> to get the latest forecast information and expected conditions.

3. Be A Force of Nature

You're an inspiration. Let people know that you have an emergency supplies kit and family communications plandoing so will inspire others to action. Share your preparedness story on social media. Help the National Weather Service build a <u>Weather-Ready Nation</u>.

Citing the Municipal Code

It's time to discuss our City Code again. This month I'd like to talk about something that is becoming more prevalent in our community, and that is the nuisance code. The nuisance code covers a wide variety of infractions. The one I am encountering more frequently now is the accumulation of stuff in front yards and driveways.

As defined in the nuisance code, when the accumulation of items becomes unsightly, emits offensive odors, or is in any way a hazard to the public, it is a nuisance. That

doesn't mean that only household garbage is a nuisance. It also applies to items that we may collect, or have no place else to put, so they accumulate and clutter the front yard or driveway, be it items or vehicles. Basically, anything that becomes unsightly is a nuisance.

The nuisance code also covers sounds. You are not allowed to generate noise above the level of a conversation, between 10 p.m. and 7 a.m.. That means working on vehicles, banging on things, or barking dogs. We all need to be good neighbors and considerate of our neighbors.


