Wastewater Supervisor Rick Mumpower

Wastewater Treatment Plant Supervisor Rick Mumpower is the picture of consistency and longevity. For 36 years, Rick has worked for the City of Florence, a testament not only to his value as an employee, but also to his ability to change and adapt through ever-evolving technologies.

Vegetation Can Cause Visibility Problems on Right-of-Ways

Concern from area residents and an increase in observed violations has prompted the City of Florence to put out this educational release regarding vegetation that causes visibility and passage problems on City right of ways, including streets and sidewalks.

Under Florence City Code, vegetation shall not obstruct clear vision at street and driveway intersections. The defined "Clear Vision Area" can be described as a triangle extending inward 20-feet on each street from where both curb lines would come to a point if the curb was not

Vegetation within the shaded area must not exceed 30" in height from the roadway surface.

rounded. See the diagram to the left for further explanation.

In addition to visibility concerns, vegetation is often observed growing onto or over sidewalks and streets, sometimes to the extent where it limits free passage of vehicles and/or pedestrians. City Code stipulates that

no vegetation should hang over a sidewalk at a height of any less than 8-feet, and a street at a height of any less than 13-feet, four-inches.

All residents should take the time to inspect their property for either of these violations.

Understanding Your City of Florence Utility Bill

City of Florence residents receive a utility bill once a month for services provided for the previous month. It is a common misconception that this is a "water bill", but it is much more than just a bill for water. The City of Florence is committed to providing residents and businesses with not only top quality water service, but also sewer, stormwater, well-rehab and street services. Like anything else, there are costs related to providing these services. Each year as part of the budget process, City Management and the Budget Committee discuss whether fee increases are warranted (due to increases in the cost of supplies, personnel and planned capital projects) in order to maintain and improve our systems and infrastructure. In order to cover costs of operations and utility enterprise debt service, the City collects these fees by way of a monthly utility bill.

The City of Florence budget for fiscal year 2013, as approved by the Budget Committee, includes increases in rates for Water (4%) and Sewer (15%) service charges as well as revising the Street Light Fee (to be named Street Maintenance Fee) and increasing it to \$5 per dwelling unit. If approved by the City Council at the June 4th City Council meeting, the rates will take effect July 1, 2012. The proposed rates and fee adjustment amount to an increase of approximately \$10 per month for a *typical** Florence Resident.

Proposed fees are illustrated below in the form of a utility bill for the month ending July 31, 2012:

RATES FOR TRASH COLLECTION ADJUSTED

The City of Florence hired a consultant (Bell and Associates) to review the rates charged by Florence's two trash haulers: Central Coast Disposal and County Transfer and Recycling. The process included a two-and-a-half month study by Bell and Associates that involved standardizing the haulers financial and operating reporting and working with the city's Environmental Management Advisory Committee (EMAC). The study and its report were funded by local haulers. Bell and Associates found that the rates the City allows the haulers to charge customers within city limits do not allow them to reach even a 1% profit margin. Therefore, EMAC made new rate recommendations to the Florence City Council. The Council then passed Resolution No. 5 Series 2012, which approved a trash hauling rate increase that will be phased in over three years. Both EMAC and the council held public hearings before making its decision. A full rate review will be done again in 2015.

Basic Residential Curbside Service - Voluntary Yard Debris:

The rates in this section include collection charges for garbage and recycling. **Voluntary yard debris collection, when available, is negotiated by the hauler.** These rates are for curbside service only. The customer places the container(s) at the curbside for collection and the customer retrieves the container after collection.
