Communities all throughout Oregon (including everywhere from Astoria to Oakridge) have been participating in the Oregon Main Street program, which is facilitated through Oregon



State Parks in order to receive assistance, training, and technical services to strengthen and revitalize their historic downtown commercial districts.

These communities build from an existing network of knowledge on how to promote a comprehensive management strategy based on:

- <u>Organization</u> of the Main Street business and property owners, citizens, public officials, chambers of commerce, and others to make sure everyone is working together.
- <u>Promotion</u> that creates excitement in downtown via street festivals, parades, retail events, and marketing an enticing image to encourage shoppers, investors, and visitors.

The Arts Mean Business

It's no secret that the arts are playing an important role in the revitalization of cities and their economies throughout Oregon and the world. From funding art in public places to creating dynamic festivals and supporting local arts programs, cities large and small have found success by incorporating art into their growth and economic planning. When the business of art plays a strong role in a community it has shown to provide a direct linkage to economic vitality. Studies show that communities see a return on investment of \$1.80 for every \$1.00 spent on the arts.¹ From Joseph to Lake Oswego, neighboring towns in Oregon have enjoyed the benefits of a thriving city arts program that increases tourism and expands their economy. Now it's Florence's turn.

In June, the Florence City Council established the Public Art Committee to develop a Florence Public Art Plan and Policy. This work, when complete, will provide the guidelines for our public art policy that will set a solid foundation for the future growth and viability of the arts in Florence. The committee is working diligently to complete the visioning and policy process and is excited to lead the way toward creating an engaged and vibrant community for all of our citizens.

- Design that enhances the attractiveness of the district including historic building 3. rehabilitation, street and alley cleanup, banners, landscaping, and lighting to improve the physical image of the downtown as a quality place to shop, work, walk, invest in, and live.
- 4. Economic Restructuring to analyze current market forces to develop long term solutions by recruiting new businesses, creatively converting unused space for new uses, and sharpening the competiveness of downtown merchants.

Between the years of 2011-2014, communities that adopted the Main Street approach saw a net gain of 83 businesses throughout the state, leading to over 850 new jobs. These communities accomplished these feats through grassroots efforts aimed at creating communities that businesses and citizens want to develop and call home.

The City of Florence will be coordinating a seminar about how this program can work for Florence in early 2016, so stay tuned. OPECON The Florence Urban Renewal Agency (FURA) wasted no time in the new fiscal year. Since July, the FURA Board has

entered into an agreement with the City of Florence to receive a \$3.7 million loan from the City. This allowed the Agency to refinance its existing debt (\$1.665 million) that carried an interest rate of 6.0% with a new interest rate of 3.25%. Additionally, the Agency will paid off an amount due to the Siuslaw Public Library District (\$210,000) and now has approximately \$2.0 million for new projects during the next two years.

Total FURA Project Budget \$ 2,000,000 FURA has begun working on two projects this fall with the assistance of consultants. The first is a streetscape design on Highway 101 and within the Urban Renewal District. FURA will collaborate with the Oregon Department of Transportation (ODOT) to include as much of the streetscape improvements as possible when ODOT repaves

The second project involves looking to stimulate development within the District to provide jobs and increase economic activity in the City. The have begun working on this through an economic analysis and development strategy with the goal of developing a strategy to put the FURA funds to their best use. The consulting firm, Leland Group, has begun stakeholder interview with local business and property owners in the Old Town and Main Street Districts. Their next step is to collect community input from citizens on our community's strengths, weaknesses, opportunities, and challenges.

City Economic Development Committee Up & Running

On May 18th the City of Florence City Council established the City's Economic Development Committee marking the cannon fire that sparked the hard work of establishing an economic development program within the City.

Consisting of a collaborative effort between the City of Florence, Florence Area Chamber of Commerce, Central Lincoln People's Utility District, and local interested business owners and citizens, the City of Florence Economic Development Committee is the first of its kind for the City of Florence in over a decade. Its mission is to:

- > Develop and Promote the Recruitment and Marketing of Business
- > Develop and Maintain a Business Retention and Expansion Program
- > Review alternatives for the organizational structure of economic development in Florence

Almost immediately upon inception, the committee established working sub-teams to meet regularly to work on these goals and established an ambitious work plan to work on efforts to promote these goals including:

- > Establishing a map and contact information list for available buildings, properties and businesses,
- > Developing a user friendly website for Florence Economic Development,
- Identifying targeted industries,
- Identifying and assisting local businesses who may be seeking expansion and/or finding it difficult to maintain their current business model, and
- Researching and reviewing potential alternatives for the organizational structure of economic development within the City of Florence and surrounding areas.

These efforts have already led to significant gains for the City's economic development efforts through coordination towards specific goals. The Environmental Management Advisory Committee (EMAC) is considering policies related to foam take-out food and beverage containers. The primary motivation for the consideration is their contribution to litter in and around the Florence area specifically in its lakes, creeks, and ocean beaches. There are a several other potential benefits, both locally and globally, from eliminating use of take-out foam containers. These include reducing the costs



to process recycling at recovery facilities due to foam container contamination and introducing biodegradable alternatives.

EMAC is surveying consumers and businesses in Florence about their use and opinions of foam food take-out and beverage containers. The survey is available on the City of Florence website at <u>www.ci.florence.or.us</u> with an extended deadline of November 16th. Please take 5-8 minutes to complete the survey. All survey responses are anonymous.

The members of EMAC will be reviewing survey responses at their November 19th meeting at City Hall beginning at 2pm. They would like to hear from local businesses in Florence on how those businesses use foam containers and what the impact of removing foam would have on those businesses.

Recorder's Corner

News from the October Council Meetings

Projects, projects, projects. The City of Florence has been working diligently on many projects this fall on items ranging from a new public works facility to upgraded playground equipment at Pepperoaks Park.

This culture of construction isn't limited to the activities of the City of Florence as there are many Oregon Department of Transportation and private projects happening throughout town as well. On October 19th, the City Council held a public hearing concerning a street closure proposed for Old Town Way from just east of Coldwell Banker Real Estate Offices to Laurel Street. The street will be closed periodically from November 1st to December 12th to allow for major construction improvements to the Laurel Crossing Condominiums located at 179 Laurel Street in Old Town Florence.

During October the City Council also completed the following:

- Negotiation with Scott Edwards Architecture to complete architectural services for the proposed new public works facility.
- Acceptance of a local government grant from the Oregon Parks and Recreation Department for rehabilitation of Pepperoaks Park and steps to purchase new play equipment at the park.
- Submittal of a proposal for Oregon Transportation funding for pedestrian and bicycle improvements on Hwy 101 between the Siuslaw River Bridge and Hwy 126.
- Submittal of a grant application for the ConnectOregon program for the second phase of the Siuslaw Estuary Trail and participation in a field trip to the site.
- Review and discussion of a proposed City Manager evaluation form and process.
- Review and discussion of a proposed grant policy for City Council discretionary funds.
- Discussion of potential planning and code enforcement changes.
- Interviews of the 11 applicants for the newly re-established Airport Advisory Committee.

Citing the Municipal Code Garbage Control & Persistent Wildlife

It's time to discuss our city code again. With the weather turning colder and wetter the wild animals are going to start getting into things, mainly garbage. FCC 6-1-8-2-L&M: Public Nuisance talks about the accumulation of trash, garbage, debris, and refuse deposited on private property. Florence residents are not allowed to accumulate garbage if it attracts wild animals, is deleterious to public health or welfare, or becomes unsightly. The problem with accumulated garbage is that the bear population seems to have increased in recent



years, and they make a real mess of garbage bags. We are at that time of year where we will be experiencing more stormy weather, which means the winds will blow trash around our neighborhoods. Wind can take a mess that a bear has made, and spread it over a large area. So let's all do our part to keep our neighborhoods clean and safe by getting our garbage dumped regularly.
