Communications Officer Angie Brog

Some of the most important work at the City is performed by the Communication Officers (CO). Their job includes receiving calls via 9-1-1 or the main Police Department number regarding crimes and emergencies, evaluating the situation, then dispatching the appropriate safety service agency (Police, Fire, EMT's, etc.). A CO's response can literally be the difference between life or death.

In addition, CO's are also responsible for assist-

ing the public at the Justice Center information counter, entering warrants, citations and stolen property records, as well as monitoring prisoners and the booking area. Angle Brog, a CO for almost five years, welcomes these important responsibilities.

"I like being able to help people, whether it be the general public needing medical attention or the police officers needing assistance to solve a crime," said Angie. "It's very rewarding to know that you were able to help someone."

When she's not working, Angie enjoys spending time with her two-year-old daughter Addison, and her partner, Police Officer Brandon Ott. She also likes traveling, shopping, camping and scrapbooking.

"Last year was our first trip to Disneyland with Addison," said Angie. "We have decided we are going to try and make this an annual trip during the spring."

Born and raised in Florence, Angle says she has a large extended family.

"It's kind of a joke at work. Everyone always says 'Ask Angie, she's either related to them or will at least know them," she said.

What is your proudest moment at the City?

"My proudest moment at the City was the birth of my daughter. She has become quite a fixture in the department, stopping in to visit. She knows all the guys by name and likes people to know she's the boss."

"Last year, I had to give CPR instructions on a small child who was a little bit younger than my daughter. I was able to keep the grandparent calm enough and he was able to perform CPR following the instructions I gave. The child began breathing again before medics arrived on scene. I received a message the next day advising me I had done a great job and the baby was OK.

"Being a dispatcher, I have received so many crazy calls and requests. Not long after I started working (for the City), I received a call from a man asking me what time the fog was going to lift. He was very upset when I told him I could

not predict the weather for him."

City of Florence Fund Structure

Governmental financial accounting and reporting is designed to demonstrate accountability to the public. The different services provided by the City are distinctly broken out into different segments or funds within the budget and financial system of the City, which provides the accounting mechanism for establishing and reporting the City's fiscal accountability objectives. In order to provide good stewardship of the resources for which the government has been entrusted with, there are often restrictions that are placed on these resources to control spending. Aside from the General Fund, the majority of the City's revenues have a certain spending purpose or restrictions. In an attempt to educate the public on the revenue composition of each City Fund, the table below illustrates the key City services or activities and their related funding sources as adopted in the 2012-13 budget document.



GENERAL FUND



Administration Services Program is made up of four sub-departments (City Manager/City Recorder/Mayor& City Council/Finance) that provide management and financial administration for all City Departments. The City Manager oversees all City operations and the City's Finances are centrally accounted for. The Administration Program is fully supported by transfers in from the City's Water, Sewer, Storm, Streets and Events Center Funds.



Community Development is comprised of the Planning and Building Departments. These services are supported 37% from charges for services, grants, and building permit fees; 14% of the funding comes from transfers in from other funds and the remaining 49% is funded by unrestricted General Fund resources.

GENERAL FUND Continued



The **Police Department** is comprised of expenditures related to the operation of the Public Safety Services and 911 Emergency Communication Officers. A longstanding financial policy of the City Council has been to fund our public safety operation with property tax revenues. Naturally property tax dollars is the City's largest unrestricted revenue stream. The Police Department is funded 80% by Property Taxes; 9% 911 Tax; 7% contract for services & grants and the remaining 4% by other unrestricted General Fund Revenues.



The **Municipal Court** is funded primarily (91%) from court fines and assessments. The remaining 9% of Court operations is funded from other General Fund unrestricted revenues.



Currently the City of Florence **Parks Department** does not have a restricted Parks dedicated revenue stream. Therefore, the Parks Department is funded solely from unrestricted General Fund revenues and donations from the community.



The **Airport Operations Fund** is supported in part by hangar lease payment revenues (14%), Aviation Fuel Sales revenue (53%), and the remaining fund expenditures (33%) is supported by transfers-in from the General Fund unrestricted revenues. Capital Improvements to the airport is only made possible by grants from the Federal Aviation Administration (FAA) and State grants. These revenues when available are restricted to the Airport capital project at hand.

PUBLIC WORKS ENTERPRISE FUND









The City's **Utility Service Enterprise Funds (Water, Sewer and Stormwater)** are fully supported by user fees. User fees are billed on a monthly basis for the services provided to each customer. The rate structure is derived in a manner that supports operational expenses as well as to support current and future debt financing expenditures. Nearly all capital projects are financed through long-term debt (bonds) that are paid off over the useful life of the asset. The user fees of the Public Works funds are restricted to each individual utility service fund (water, sewer and stormwater). At times the City is a recipient of a grant that provides funding to do an additional infrastructure project that is restricted to the project that the grant funding was received for. Grant funds allow the City to complete more projects on the deferred capital projects list faster than originally anticipated.

PUBLIC WORKS ENTERPRISE FUND Continued



The **Street Fund** is supported by a wide-variety of revenues that are all restricted to the maintenance and betterment of the City's transportation infrastructure (streets, sidewalks, bikes and trails). The City collects a Street Maintenance Fee by way of the monthly Utility Bill which is restricted to the preservation of our existing city streets. 45% of the Street Expenditures in the 2012-13 budget are from the State & Federal Transportation Departments; 16% is supported by the Street Maintenance Fee; 13% is derived from the State Highway Tax; 6% is the Urban Renewal Grant for the Bay Street improvements and the remaining 20% of expenditures is supported through debt proceeds, fund balance and street assessments collected on local improvement districts.



The **Florence Events Center** (FEC) is a regional conference and events center that draws tourists and potential future residents to our community. It has been the City Council's financial policy to fund some of the FEC operations with Transient Room Tax (TRT) revenues (30% of the FEC 2012-13 budget). In addition, marketing to tourist expense is funded by the RTMP grant from the


County (11%) and Building space rental fees and commissions from Concession and Ticket Sales make up 16% of revenues. The Friends of the Event Center donations for equipment improvements made up 8% of the 2012-13 budget with the remaining 11% funding gap coming from FEC fund balance (reserves).

Vegetation Can Cause Visibility Problems on Right-of-Ways

Concern from area residents and an increase in observed violations has prompted the City of Florence to put out this educational release regarding vegetation that causes visibility and passage problems on City right of ways, including streets and sidewalks.



Under Florence City Code, vegetation shall not obstruct clear vision at street and driveway intersections. The defined "Clear Vision Area" can be described as a triangle extending inward 20-feet on each street from where both curb lines would come to a point if the curb was not rounded. See the diagram to the left for further explanation.


In addition to visibility concerns, vegetation is often observed

growing onto or over sidewalks and streets,

sometimes to the extent where it limits free passage of vehicles and/or pedestrians. City Code stipulates that no vegetation should hang over a sidewalk at a height of any less than 8-feet, and a street at a height of any less than 13-feet, seven-inches.

All residents should take the time to inspect their property for either
