Resource Assistance for Rural Environments (RARE) Participant -- Katya Reyna

Established in 1994, RARE is an AmeriCorps program administered through the University of Oregon's Community Service Center and allows a unique opportunity for postgraduates to work within a rural community, assisting in various projects related to urban planning, natural resource planning, food systems and economic development.

FACTS ABOUT ANNEXATION

here are many things a citizen must consider when analyzing their alternatives for having their home or business annexed to the City of Florence. The City of Florence provides many services including police protection, parks, code enforcement, planning/building, and city administration, which would be available to citizens upon annexation to the City of Florence. However, there is a cost-benefit analysis that every resident must do in order to decide if annexation to the City is right for them. For this reason, and in light of common misconceptions, the City has prepared a fact sheet on annexation which is available on the City of Florence website at http://www.ci.florence.or.us/planning/annexation-fact-sheet. Below is simply a sneak preview of the information contained in that sheet.

Standard Recurring Taxes/Fees

<u>City Property Taxes</u> – The City of Florence property tax rate (regular & bond) is \$2.85 per \$1,000 of assessed value. Thus a property valued at \$200,000 would see a tax increase of \$570/yr upon annexation.

<u>Monthly Utility Fees</u> – The City of Florence has four utility fees; water, sanitary sewer, stormwater, and street maintenance.

- Water fees are only charged to those occupants who use the City's water system. Heceta Water District would continue to be the service provider for residential areas north of the City limits and west of Hwy 101.
- The average sanitary sewer bill for a single family house is \$48.27 per month. If the house is not connected to the system, there would be no monthly charge.
- The current monthly stormwater charge for a single family house varies from \$5.00 to \$8.00 per month depending on the size of the lot.
- The Street Maintenance Fee charged for a single family house is \$5.00.

One Time Development Related Fees

<u>Sanitary Sewer Connection</u> – <u>The City does not require connection to sanitary sewer upon annexation</u>. Thus, it is possible to have city services such as police protection without sewer connection. If sewer connection is desirable, the cost to connect is estimated to be between \$9,000 and \$15,000 depending on the number of property owners who choose to participate in sharing the cost, and the complexity of extending the service. Other costs to be considered include the cost of abandoning the existing septic system, sanitary sewer connection fee, system development charges for sanitary sewer, stormwater, and streets. Estimates on those costs are discussed in the full annexation fact sheet.

Other Development Costs – It is important to note, that annexation does not require installation of sidewalks, street lights, or other types of public improvements. Many neighborhoods in Florence do not have these sorts of improvements. Only new development or major redevelopment would be required to comply with current development standards.

The City of Florence has a process for properties wishing to annex into the City of Florence.
