Brief Overview of What You Wish to Discuss

"Emergency" housing and Bob Teter's limited and limiting, nonhousing emergency definition (spoken at the last open house), one that only applies if at all to natural disasters and similar "event" focused situations and not to the now cumulative, wide-spread human misery being suffered by our neighbors who are not and have not been humanely sheltered. It is unreasonable and unconscionable to assert that people without options "age out" of emergency housing status somehow because of our community's long-term failure to act or take into account all of us, it's failure to consider all of us in meeting its obligation to act in the public's interest. A limited definition, like that spoken by him, creates barriers that are inconsistent and incompatible with controlling Oregon state law related to housing.
