Dear Council Members:

I respectfully request that you move forward as quickly as possible with this emergency shelter proposal. The shelter's establishment and first year of operations are funded and will provide a missing piece of a coherent response to terrible conditions that so many Florence residents face.

Councilors Meyer and Carp. I have read some of your statements and hope you will more deeply learn about and consider the facts of Florence's emergency. If the councilor now attending our local court proceedings has not fully informed the entire council of the nature and extent of the eviction problem in town, I hope that person will do so and also inform the public more generally. The Chamber of Commerce can ignore humanity and dress pretty for parties – it is a corporation. The Chamber can speak for the city and make decisions if and when we the people adopt a fascist form of government. We are not there quite yet. For now, you are the government and it is your responsibility to protect and serve all of us, including those who have the least. The councilor attending court can set the record straight if I misspeak, but in Florence as in the rest of the country, the fastest growing number of people without housing are elderly women. The words, "it is a lifestyle 'they' choose" are so very false, are dangerous to our fragile neighbors. And they mislead the public who needs representatives who seek the truth and share the facts without regard to politics of prejudice.

I am attaching a July 3, 2019, missive sent to the planning commission via a former employee from Sherry Harvey so that it can be made a part of the record of this process of dealing/not dealing with the fact of homelessness in our community, as well as a September 10, 2019 letter from Florence Food Share noting that, four years ago, our Food Share served 227 unique homeless individuals and that with Florence's lack of long term affordable effective housing, there is no end in sight.

The City of Florence remains subject to the holdings in the *Boise* federal court decision, which was recently ratified by full 9th Circuit panel. Unless there is a place in the City where a bed is available to them, houseless people are allowed to sleep, unmolested, on public property. Festivals and car shows are ripe opportunities for bringing that point home to any town that thumbs its nose at its responsibilities to the wider and poorer community. If Florence does not start actively dealing with the problem it has so long ignored, it cannot complain when coercion and financial penalties are forced on it.

This emergency shelter proposal is only one facet of the solution and it is a very good start. It has a good plan and adequate financing. Hopefully we can all learn from it so that forceful, dictated and costly remedies for wrongful conduct are not required. And you could help. And if you did help you would learn how misguided and harmful the stereotypes and harsh words are, to the people at whom they're directed and to yourselves and your community.

For your upcoming work session on revised building codes, I have summarized the results of the survey that was given to the public to make it easier for you, plus I attached the original results. The consultants did not share the result details with the CEDC committee prior to their vote.

Florence Housing Survey June 20, 2019 (questions are shortened and simplified. The full document is attached)

Note: Oppose = those who answered "Oppose" or "Strongly oppose". Support = those who answered "Support" or "Strongly support", "Neutral" was ignored.

1. Rename residential districts from Restricted Residential to low-density and *single-family to Medium-Density* . . . etc. (which allows tri-, quad-plex and clusters in single family residential)

Oppose 48% Support 41%

2. Reduce minimum lot sizes

Oppose 50% Support 41%

3. Expand housing options, including: Duplexes/duets and cluster housing in Low - Density residential.

Oppose 50% Support 44%

4. Allow second-floor residential uses in the Commercial, Old Town, and North Commercial zones

Oppose 43% Support 44%

12. Provide option to meet parking requirements through an on-street credit

Oppose 50% Support 36%

13. Provide option for residential development to meet parking requirements in

part through provision of a driveway space

Oppose 27% Support 57%

14. Implement the following parking standards for tri-plexes, quadplexes, multi-family and cluster housing: 1-bedroom: 1 space per unit 2- bedroom: 1.25 spaces per unit 3-bedroom: 1.5 spaces per unit

Oppose 45% Support 36%

15. Allow phasing for large projects

Oppose 31% Support 45%

16. Allow "key", "butt" and "flag" lots with appropriate access

Oppose 29% Support 51%

Note: Items that were clearly "opposed" by the public were ignored by the consultants and no adjustments were made to the document which went on to the next step of approval.

I am writing to express my wholehearted support for the proposed emergency shelter proposed by the Florence Emergency Cold Weather Shelter Committee. As a community with a similarly structured site, focused on assisting individuals with transitioning from homeless to housed, Coos Bay can attest to this model and the positive impact it has had within our community and for those experiencing homelessness. Coos Bay's project, Coalbank Village, is fully operated and managed by The Devereux Center and has proven to be a crucial step towards addressing the pressing issue of homelessness and providing support for those in need.

Having awareness of community concerns regarding potential increased crime, negative impact on tourism, and an increase in the homeless population due to the provision of services, suggests that the city of Florence is engaging community input and providing educational opportunities which will assist with general community consensus. Coos Bay's experience with similar community concerns has shown that the benefits of Coalbank Village far outweigh any perceived drawbacks.

First and foremost, the provision of emergency sheltering offers a safe haven for individuals and families experiencing homelessness. By providing a stable and secure living environment, these vulnerable members of our community have opportunity to rebuild their lives and regain self-sufficiency. As with Coos Bay's Coalbank Village project, Florence's project can not only contribute to improving the lives of those in need but will also strengthen the fabric of the community by fostering compassion and unity among its residents.

In regards to concerns regarding potential increased crime, research has consistently shown that well-managed shelter projects have a neutral or even positive impact on local crime rates. Such facilities are typically subject to stringent security measures and close monitoring to ensure the safety of both the residents and the surrounding neighborhood. Collaborating with law enforcement and implementing effective security protocols will be essential in maintaining a secure environment for everyone. This is exactly the approach taken by The Devereux Center in the early stages of developing the management and security guidelines for Coalbank Village. Because of this early effort, Coos Bay Police Department has responded to the site minimally.

Though there may be a concern regarding a perceived impact on tourism, it is essential to consider the bigger picture. A compassionate and caring community that supports those in need is a powerful draw for socially conscious tourists. Moreover, by addressing homelessness, we can enhance the overall appeal of our town or city as a welcoming and empathetic destination. Initiatives that demonstrate a commitment to social responsibility have been known to attract visitors who seek to support local communities and contribute positively to the places they visit. Coalbank Village has proven to be a well-managed facility, with intentional effort towards minimizing the potential of a negative outside view. Coos County's overall tourism numbers are on the rise, following the pandemic freeze, and show no signs of stopping, a clear indication that serving the homeless population can be done without reducing the tourism draw.

Finally, the concern about the potential increase in the homeless population due to the availability of services, has not proven to be factual for Coos Bay. For Coos Bay, and likely for Florence, it was crucial to understand that homelessness was already a reality. Providing emergency shelter and services does not create homelessness but rather addresses it in a more humane and proactive manner. With proper coordination of services, ability to effectively identify and provide assistance to those genuinely in need is met, ensuring that the benefits extend to those who truly require support.

Coos Bay has found that Coalbank Village has been a tremendous asset to our community. With appropriate management and proper planning, the community impacts can be minimalized. And through this effort, and the City's partnership with The Devereux Center, 40% of the individuals that have been residents of Coalbank Village have successfully transitioned to supportive housing.

RE: Citizen Input -- Proposal to Build a Full-Time Homeless Shelter in Florence

I am writing to you as a citizen of Florence since 2018 who is involved as an occasional volunteer at the Methodist Church's Thursday Free Lunch program and a fairly consistent donor to Food Share. I am also a member of the Florence Unitarian Universalist Fellowship, which adopts various community partners in Florence to support with our donations.

I am strongly in support of the opportunity being offered to Florence to accept \$500,000 from the State of Oregon to create a full-time shelter for the homeless.

Yesterday I learned from Rev. Dr. Ruth Miller, who is one of the ministers serving the Florence Unitarian Universalist Fellowship, about her extensive experience serving the homeless. She has owned property in Florence, although she is not currently a resident.

The following is a summary of what she shared yesterday at church as it relates to her first-hand experience with addressing homelessness in the communities where she has served.

In the 1980s-early '90s, Ruth Miller worked with community development processes in Portland. When the boarding houses were made illegal and the federal government shut down the mental institutions there was a huge increase in the population of "Skid Row" around China Town. A couple agencies ran shelters, which provided minimum services and kept most of the folks who needed them from wandering into other parts of the city. During the '90s a couple nonprofits were formed and began to convert older buildings, and later build new ones, as "SRO" facilities: basically, dormitory structures where each resident had their own bed-bath space with a shared lounge-kitchen space. That made it possible for those with low-paying jobs or low monthly benefits to have a warm dry place to call home. It also launched development in the area, which is now the artsy condominium-and-apartment community known as "The Pearl District."

From there, Ruth moved to Corvallis, where a nonprofit corporation raised funds and built several subsidized housing projects, providing long-term rentals for low-income (less than 80% of median) families. Those structures have onsite management and are still good-looking contributions to the community. Also, several houses that were scheduled to be torn down were moved to what had been a parking lot - and they're still looking good. Over 5 years, then, the non-profit provided about 50 units of low-income housing at no cost to the taxpayers, that are simply part of the community today.

From Corvallis, Ruth moved to and worked in Grants Pass in the late 90s early 2000s. The local Gospel Mission shelter was struggling and received funds to create a much larger one on the edge of the tourist district, Old Town, next to the railroad tracks. They built a very attractive building with meeting rooms and a library and dining room, and a wing for men and another for

women/children. They built raised bed gardens to grow much of their food, and offered regular study groups as well as meals and both transitional and emergency shelter. In spite of everyone's worst fears, there was no increase, but actually a decrease in needy people in the tourist shopping area, and a safe place for the most vulnerable in the community. Over the years, it was learned that some men simply don't like to live in buildings -- and a few of the volunteers were able to make it possible for those folks to have a safe place to camp on the edge of town and earn a little money doing small jobs.

From 2007 to 2020 Ruth lived and worked in Gleneden Beach and helped form a transitional home for men at the south end of Lincoln City. They learned then that there are many men who live along the coast who don't ever want to live in buildings and would have nothing to do with us. But in those few years that the City let our group use one of its vacant properties where housing for 5-8 men at a time helped 29 get their lives together, find work, and move into long-term housing.

In Gleneden Beach, as in Grants Pass and the SROs in Portland, there was a resident manager who got to know the residents. Social service case management was available, and groups worked with churches for those who were seeking spiritual counseling and support, set the residents up with 12-step programs, and worked closely with the Goodwill Employment Services staff.

I sincerely hope the board will consider Dr. Miller's vast experience in all these projects. The net result was a decrease in local homelessness without any increased cost to the community, and with no degradation of the neighborhood because the projects are well-designed and well-managed by people who live there.

We had everything from domestic violence, health issues, pregnancy & whatever caused them to not be able to afford a place to live. The day shelter allowed them a place to go to get clothing, toiletries & a meal. I wanted to be of service & had no experience directly with the homeless. When I started on my first day I was nervous because I felt disconnected from "these women". It was not my world & I didn't understand who & why they could end up without a home. My first job was to help get clothing so they could go to job interviews. The first woman I met had a bandage on her face. I asked why & she said it was a gunshot & she was in the wrong place at the wrong time. I said from my ignorance, wow I know how that must feel. She said, no you don't & you have no idea what I deal with in the streets. I apologized & said yes, you are right I do not. From that point on, I started to get the plight of the homeless & meet them as my fellow humans. I worked with women who had a place to crochet, write poetry, & feel safe for the day. It opened my eyes to humanity & how we are not that different from those who fell through the cracks. The home graduated many women who found jobs, & became advocates for others who were struggling. This was a win/win of compassion & what is possible. Thank you.

Letter in Support of Permanent Emergency Shelter Project in Florence, Oregon

Greetings to the City Council:

My name is Rev. Dr. Jennifer Yocum. I live in Florence, but I supervised the Severe Weather Shelter at Forest Grove United Church of Christ in Washington County, Oregon for 10 years from 2008-2018. I've been involved in services and issues related to homelessness since the 1980s and I have the following thoughts to share, First, we are already paying for services for those experiencing homelessness. We're just doing it in the most expensive, least effective means possible, and second, the accompanying moral cost of not attending to the multiple crises around homelessness is breaking our communities apart.

Let me attend to my first claim, that our community is already paying for homelessness. People experience homelessness for any number of reasons, but homelessness tends to be accompanied by joblessness, deferred health care, trauma, and harmful self-medication strategies. Those who experience chronic homelessness often have to cope with physical disabilities, mental illness and/or addiction and crime or misdemeanor records that impede future job or housing prospects. In the shelter world, we used to say that our guests ended up with a bed from us, the jail, or the ED, and we were by far the cheapest option. But letting homelessness be addressed by the docs (ED) or the cops (Public Safety) or shelters alone, does nothing to solve, stem, or shift unhoused people out of homelessness.

Communities wind up paying for homelessness through funding social service benefits which are insufficient to maintain housing or wellness, paying for emergency room care for non-urgent conditions, funding unnecessary public safety responses which may include court proceedings and jail time, sanitation responses, and paying for employer costs for tending to issues stemming from people sleeping out on their property.

The list below provides an incomplete summary of the kind of costs that can arise from NOT attending to homelessness in a coordinated fashion.

1) The average cost per Emergency Department visit in Oregon for non-emergent care, such as acute bronchitis, is \$2200.

- 2) The cost for a jail bed in Lane County is \$155 per day (figure from 2019). Cost per inmate per year is \$88,740. Homeless people are being kept because they don't have the means to make court appearances and those jail costs get passed on to taxpayers. (https://usafacts.org/articles/how-much-do-states-spend-on-prisons/)
- 3) The current budget for Public Safety in Florence is \$5.75 million, more than 1/3 of operating expenses for the whole city. (Source, City of Florence Adopted Operating Budget). If even 10% of those calls to police and fire services are for those experiencing homelessness, that's already half a million dollars that does NOTHING to actually attend to the root problem.

Homelessness on the scale we're seeing here in Oregon is a moral catastrophe. We've seen homelessness jump 23% from 2020-2022, primarily due to spikes in housing costs, and our state has the third highest population of homeless

people in the country. The fall into homelessness can lead to severe depression for adults and children. (https://www.oregonlive.com/politics/2023/04/oregons-recent-growth-in-homelessness-among-largest-in-nation.html)

The sharp divide in income, opportunity, and accessibility echoes the divide across politics and civility. It builds distrust, fosters dissent, and tears at our capacity for community resiliency. Accepting homelessness as a chronic and growing condition, about which "nothing" can be done, fosters hopelessness and fear for the housed and unhoused.

In conclusion, the best most effective plans to address homelessness have to include safe, supported permanent housing. The plan to invest in emergency shelter here in Florence is one step toward that goal. It is not enough, but it provides an important next phase to continue the work of SOS, several local churches, and those individuals who have worked so hard for so long to make sure that everyone in Florence has a home here.

My husband and I support The Florence Emergency Cold Weather Shelter (FECWS) plan to partner with the Devereau Center to create a full-time shelter for the homeless. We believe that not only is it the "right thing to do" but that it will eventually be seen as an asset to the community, once it is built and the shouting dies down.

As you may be aware, there has been quite a commotion on Next Door this past week regarding the proposed shelter and there are both pro and con opinions. We have posted in favor of the shelter. Most of the negative comments seem to be on the type of "I don't want a shelter in Florence." We have posted twice that the City of Florence does not really have a choice to provide shelter or not because of the Court Cases of Blake v City of Grants Pass (2019) and Martin v Boise (2017). I am copying and pasting our second Next Door post so you can read our post plus have the link to the article.

I earlier posted a link to the Court Case of Blake v City of Grants Pass and am again posting it. I don't believe that those opposing the shelter understand what the City of Florence (or any city in America) is up against. The precedent case is Martin v Boise. In 2017, the U.S. Supreme Court upheld the District Court judgment for the plaintiff. In 2019, the District Court ruled in favor of the plaintiff in the Blake v City of Grants Pass case. The U.S. Supreme Court declined to review, thus leaving the District Court decision intact. THIS IS ESTABLISHED LAW. Essentially, this means that a city cannot eject an unhoused person from any public land unless there is available HUD shelter space. Failure to provide shelter for those who are involuntarily unhoused amounts to a violation of the 8th Amendment: cruel and unusual punishment and imposition of excessive bails. Before going to the City Council meeting, please review the Court Case. No one should attend with the intention of shouting down the Council until they read this. You wouldn't want your ignorance to embarrass you. https://casetext.com/case/blake-v-city-of-grants-pass-1

We believe that if the Established Law of the two cases was reviewed with the public at your meeting tonight, it might help defuse a lot of the negativities toward the Council's proposal for the shelter.

I was a Certified Real Estate Appraiser in the state of California (Orange County) for 22 years. It is a difficult thing to prove whether a shelter has a negative impact on property values. The reason why it is difficult to measure is that sale data have to be studied both before and after the shelter is built. Other factors besides the shelter have to be extracted from the data; i.e., market increases/decreases due to other factors such as interest rates, increased traffic not due to the shelter plus more. It is a difficult thing to measure and no person, especially one who has not had experience in valuation of this type, can make a projection of what the shelter will do to property values.

We live full-time in an unincorporated area of the Florence zip code (The Reserve at Heceta Beach) and understand if you do not take into consideration our choice. However, the proposed site for the

shelter will be in closer proximity to us than those who live in the Downtown area, so we hope that our preference for the shelter will count for something. We plan to be at the City Council meeting tonight and to be quiet while the Council and Devereau present their proposal. We know we will learn much.

Letter in support of the proposal for a year-round emergency shelter in Florence

I watched the meeting of the Florence City Council on August 3rd when there was a presentation and discussion of the proposal for a year-round shelter in Florence. The information presented was very detailed and based on several years of experience by the Devereaux Group in Coos Bay, who will also oversee the Florence project.

As a resident in Lane County outside of the jurisdiction of the City of Florence, I appreciate many of the amenities that are available to everyone in Florence. Among them are the charming Old Town area, the recent improvements at Highway 101 and along Rhododendron Drive, the playgrounds and other facilities at many large and smaller parks, the public library, and a well-respected Police Department, Fire Department and Mobile Crisis Unit.

Thank you Mayor and City Council members for investing so much time and energy into thoroughly researching this proposal to start a Florence Emergency Cold Weather Shelter. And thank you for allowing all of us to voice our opinions, ask questions or make suggestions on this topic.

I listened carefully to your Aug. 3rd work session on this proposal and although many of my concerns and questions were dealt with satisfactorily, I do have the following comments for your consideration:

- 1. How many calls to law enforcement are projected to be generated by the new shelter based on the Coos Bay center numbers over the last few years of its existence? Do our local law enforcement officials consider those numbers to be reasonable within the scope of their finite resources?
- 2. Securing permanent housing in our community seems to be an important outcome for this shelter for both the newly hired staff and the residents transitioning out from the shelter. Do we have affordably priced housing units for these folks? Do shelter staff assist residents with securing this housing? What is the success rate for securing and keeping this housing over

each year based on the Coos Bay center stats since they began in 2018?

- 3. What happens if costs exceed those projected by the grant for either the site prep or the administrative/operating expenses? Is the city on the hook financially in any way?
- 4. Finally, I support starting this Emergency Shelter here in Florence and using our tax dollars to assist this population with a proven model to break the cycle of homelessness. If this new shelter can help 15, 20, 40 folks/year get off the streets, out of the woods and into a warm, safe and controlled environment, then it's that many less people roaming around in our community. We will all be safer.
- 5. This state/county \$500k grant, by its very nature, will impose many tightly regulated protocols on the whole process, so the impact on city staff should be minimal. There will probably be site visits by county or state officials to assess progress and keep the project on track; any issues will be identified and resolved before they flare up.

Assuming that the answers to my questions are all within reasonable limits, I encourage the Mayor and City Council to approve this proposal.

To Florence City Council,

There has been a lot of misinformation circulating lately about homeless issues. I want to share the facts as I know them from working with the Cold Weather Shelter for the past five years. The Presbyterian Church, First Step and the Florence Emergency Cold Weather Shelter (FECWS) are all separate organizations. The primary location for the FECWS was originally at the Presbyterian Church. After covid hit Pastor Woods stepped down as chair of the FECWS and churches were no longer available as shelters. Because of this, First Step granted use of a portion of the three acres owned by First Step north of Fred Meyers to the FECWS. Funds and small shelters were provided as covid relief with the cooperation of the city, county and state.

FECWS, with Pat Burke as chair for the first two years during covid, worked in collaboration with First Step, the city of Florence, and many volunteers from the community to develop the site. At the end of this winter season, the First Step Board informed the FECWS of their plans to develop the property. This means FECWS needs to relocate. The shelter was open more than 80 days this past season and was usually full. This demonstrates the need for shelter.

After getting to know many of our "resident" homeless, I have come to understand that some, perhaps more than half, are engaged in some sort of substance abuse. For many, alcohol is their biggest problem. There are also mentally handicapped, socially awkward folks, and some are just a victim of circumstance. I have only found three or four people in my time with the shelter that I would consider truly dangerous. For these individuals we involved the police. Most of our guests are exhausted from being in the elements when they come to us. They shower us with gratitude and appreciate the meals and dry warmth.

I think the residents benefit from their time in a structured facility where rules, trash cans, and bathrooms are provided. The community benefits from this as well. Providing shelter helps protect the city from lawsuits. It also helps emergency services, and it is my understanding that if no shelters are provided the homeless can sleep in parks and other municipal areas.

Last evening after attending a movie here in Florence, I stopped at the grocery store which is in the same plaza as the theater. I was shocked, intimidated and frightened when I saw a man laying on the sidewalk where the baskets are kept. He was awake, but "not there". This is not the first time I have seen people in this state, but because it was the night before the City Council meeting relative to building a permanent homeless shelter here in Florence, that I felt compelled to write you my feelings. Since I have no training to dealing with these situations, how can I feel comfortable thinking this situation will improve by simply building a permanent shelter that, incidentally, only addresses men as I was led to believe. What about homeless women and children, who need to be able to grow up into good and valuable citizens. Aside from that, would this man have even been capable of getting to a shelter and would he even care about getting to one? If a person has to be drug free to even enter a homeless facility, would this person, who was obviously high on drugs, even be allowed to get help there? I think this is a much bigger problem than homelessness. Is homelessness caused by drugs or alcohol or mental illness, or not being able to afford a home within their means? Will any of these new supposedly affordable, low income apartments currently being built afford any remedies to these homeless folks? To the members of the Florence City Council for consideration during the Special Meeting 8/14/2023:

My principal concern is the uncertainty of funding for the proposed homeless shelter past 2025, and the possibility that the citizens of Florence would be taxed to make up the deficit.

As I understand it:

- Lane County will provide approximately \$500K only for the next two years.
- These funds will be used to construct a facility, hire staff, operate the facility, purchase a vehicle, and pay for other expenses.
- The Lane County funding is programmed through 2025 and specific funding beyond that has not been identified either as to source or amount.

My concern is that once the facility has been constructed and put into operation, and the Lane County funding has dried up, and no additional funding sources can be found, continued funding of the facility will fall on the citizens of Florence. Florence is a small city with a population of less than 10,000 and a <u>taxpayer</u> population of significantly less than that. Continued funding of the facility through Florence taxes would place an unwelcome and onerous burden on the taxpayers who would receive NO direct benefit from these taxes. Further, the homeless individuals who are the beneficiaries of this largesse contribute little to nothing to the community in return. There are existing facilities for the homeless in Eugene that are funded, staffed and trained to deal with the homeless.

<u>Recommendation</u>: instead of accepting the Lane County funding with future funding not nailed down, <u>do not build the proposed homeless shelter</u> and instead, provide van transportation for these individuals from Florence to Eugene homeless shelters. Expenditure of Florence taxpayer funds to support transporting homeless to certified homeless shelters in Eugene would benefit both the homeless individuals and the citizens of Florence. Win-win.

- * Florence is experiencing a housing crisis, which in respects is a positive thing. Our city is a destination city, where thousands of tourists travel from all walks of life to enjoy the wonderful eateries and the scenic coastal attractions that it has to offer. The city currently enjoys a comfortable revenue from its local small businesses, tourism, and a retirement community, made up of nearly 43% of the population.
- * Building Permanent Homeless Shelters will degenerate the Image and Ambiance of our fine City. Visitors will go elsewhere. Residents will either move to areas not affected by Homeless Shelters and bad policies, or suffer the consequences of attracting more crime, violence, drug abuse, over saturation of our already overburdened hospital services, to include police and fire resources. Small Businesses have already taken a hit from COVID, but increased homelessness and adding Shelters will close more businesses, and others will leave to cities that haven't made this unfortunate mistake. Our neighbors to the North, South and the East of us, have experienced a road to ruin with failed decisions made by their elected officials.
- * As a real estate practitioner of 43 years here in Florence stated, it is their "sincere opinion that this proposal, if initiated, will definitely repeat the history of Portland, Seattle and San Francisco. Homelessness, wrecked vehicles, abandoned vehicles, and trash will only draw in more of the same. The experiment of enabling have a long history of evidence that

does not end well, such as devaluation of home properties and quality of life."

- * The city will risk losing their leverage on revenue. The proposed cite will gain zero in revenue, but expend \$5,000 per year in liability insurance. The State has earmarked \$637,000 towards this project's start-up, which expires in January 2025. There is no guarantee the State will replenish these funds once they have been exhausted. Is it worth going "All-In" to lose our city, our tourism, and our retirement community, whom many have chosen Florence as their final destination?
- * This proposal is "a not so good idea". There's too much to lose, and nothing to gain. On August 3, 2023, it was proposed that "Only Florence Homeless", also referred to as "Guests," will be eligible for a spot into the Shelters. That same proposal, on 2 separate occasions suggested "moving Guests" from shelters in Coos Bay, to Florence. The proposal also mentioned that the "Goal is to move "Guests" from "unsheltered to Affordable Housing". Our current housing shortage, over burdening our hospital, our Fire and Police Departments, and the fact that many of these homeless have Drug and Mental Health Issues, Florence just does not have the facilities or qualified professionals to address these issues. It will be nearly impossible to obtain such a goal. As per the Oregonian of February 21, 2023, nearly 90% of Homeless Portlanders swept from encampments are back on the streets; just 1% got permanent housing. The Washington Standard, dated August 6, 2023, headline news, "Stuck: Average Length of Stays in San Francisco Homeless Shelters Skyrockets".

With variables yet disclosed, the logistics to successfully operate, manage and maintain this proposed shelter, will be yet another disappointing failure on the West Coast.

In the strongest terms, we oppose this plan.

I am against the permanent 21 unit homeless shelter as a tax paying long time resident of Florence.

Has anyone thought of the criminal aspect of bringing in even more homeless people than those who are already here? Offer free food and shelter, and they will come many with criminal intentions as we've seen in other cities. The city of Florence has a population of approximately 9,553. The number of homeless already here is not really known exactly, but the numbers are increasing consistently. Just drive down some of the streets and you'll see large numbers of motorhomes and trailers many in very poor condition, leaking oil, and trash piled up around them. Then there are the homeless who reside in tents, most of which also have trash piled up around them. Some homeless just live in the open with their belongings either in a backpack, trash bags, shopping carts, etc.

To invite more to come here is a huge mistake. There are 21 units available and from what I've seen, many are walking from all directions to Florence to possibly get one of these units. There is no doubt in my mind that the crime will skyrocket as the homeless population continues to grow. I know this from personal experience and also from friends who have had bad experiences with a few of the homeless. I have been attacked twice recently. Once a woman who was ranting and raving came running at my car and tried to get in as I was stopped at the exit of Safeway. She tugged at the handle of the passenger side door screaming obscenities the entire time. I was able to drive off quickly and relieved that she let go. The second time I was coming out of the Casino where a shirtless homeless man was spitting at me, shaking his fist and screaming things I couldn't even understand. A woman came over to see if she could help and we quickly walked to a nearby bench and sat down. I was definitely shaken by this as his fists were too close for comfort. A few more minutes passed and a security officer from the casino came out to address the situation. In yet another situation, a friend was chased by a homeless man who had a skateboard in his hand and was trying to hit him with it. I'm sure I'm not the only one who has encountered a violent homeless person in our town, just ask around. This will happen even more when the homeless population explodes in our town.

The more that come, the more crime it will bring. We've all seen the crimes committed in other cities with large homeless populations. Stores are closing because of theft and those that don't close lock up everything so it takes hours to get any shopping done. People are being robbed, beat up and seriously injured. God forbid some innocent retiree or any other tax paying resident gets killed at the hands of a mentally ill or drug addicted homeless person. I do have compassion for the homeless, but I also have compassion for our tax paying citizens who are now living in fear, afraid to leave their homes.

I'm unable to attend the meeting due to a statewide previously scheduled Zoom meeting.

Though I am not opposed to providing a hand-up, I believe there are criteria that need to be addressed and answered to the satisfaction of local taxpayers. It's hoped that in two years we won't be pointing fingers and saying, "We told you so, and you didn't listen."

There is no easy answer to this problem. Legalizing drugs did not help. Instead, it opened the door for many people who have decided that "I can use more frequently, or I can always keep it on my person," whereas before they were a little more discreet about it." And, with Oregon's liberal stance, it has invited drug users who know there won't be consequences.

Just in the last few weeks I've seen an increase in the number of apparent homeless. Especially a couple of them on Hwy 101. One was across the street from Krispy Krunchy Chicken loudly conversing with himself and tossing something into the shrubbery behind him.

Here are facts and my questions:

According to Lane County:

The total number of people experiencing homelessness has increased by 72% in the past 5 years. (The question not being asked is where they are from. Many have come into the area because they know handouts are available.)

FACTS: Devereux Center (Coos Bay)

- 80 beds
- Azalea Building was donated
- Per Charity Navigator: 68% rating (2 star) https://www.charitynavigator.org/ein/930822406
- Team of 20 providers come to the Navigation Center 1st and 3rd Tuesday of each month including Doctor and Physician Assistant, Nurses, Clergy, Representatives from a multitude of service agencies ie Adapt, Coos Health and Wellness, Housing Authority
- Coalbank Village is a low-barrier 24-unit emergency shelter built and managed by the Devereux Center in Coos Bay with support from many community partners.

Proposal for Florence

- "Opportunity to bring to \$500k and new jobs into the Florence community."
- 30 bed shelter utilizing existing pallet shelters.

Questions:

• The diagram provided shows 21 shelters. How will those 21 shelters house 30 people?

- Since every business in town is in need of employees, what makes the council think these positions will be staffed?
- Though current statistics are not available, an article from The World newspaper showed there were 87 law enforcement calls in 2018 and 196 in 2019 in Coos Bay to the Devereux Center. Granted, they have more people there, but is our PD staffing adequate to respond to additional calls?
- Since our medical providers in Florence can't keep up with the current needs, how will current providers be able to meet additional needs?
- Are there statistics to support the success of "Addiction Recovery Centers?"
- What community partners will support such an endeavor here?
- What happens to funding after June 2025?
- Given the extreme delays in construction here, how can this be accomplished in the time frame that is proposed? Will the work be done by local contractors?
- A study shows that the presence of a shelter appears to cause property crime to increase by 56% within 100m of that shelter, with thefts from vehicles, other thefts, and vandalism driving the increase. Is the City of Florence prepared to increase law enforcement in this event? The cost to add one officer is \$46,000- \$100,000. Where do you expect those dollars to come from?

Before the study was released, the Joint Office said it provided a 7% cost-of-living adjustment for most contractors in 2023, which will increase to 8% in 2024."

With the lack of affordable housing in Florence, where will the staff live?

Though I haven't been able to verify this, I've been told by two independent sources that our local Boys and Girls Club had funding cuts to support the homeless shelter.

I urge the City Council to get a grip and not just look at \$\$\$ coming in to get something started that the community isn't prepared to sustain.

As long term resident homeowners of Florence for the past 22 years, we are writing to express our concerns regarding the proposed additional permanent homeless shelter. We do care about those individuals who find themselves in situations that lead to homelessness but think the best remedy for this issue is helping them by providing essential services which address the root causes, such as mental health services, drug rehabilitation care and job training skills. Addressing the root causes would provide a better long term solution rather than simply building more shelters and enabling them to continue living in the same situations that led them to first become homeless.

We don't believe that enabling people to continue living in their current situation will benefit themselves or society unless those root causes which led them there are first addressed. Providing only shelters without the real help that they need, is truly not a compassionate approach.

Crime greatly increased when the current "First Steps" homeless shelter was opened just north of Fred Meyer. A former Fred Meyer employee of 15 years reported that the theft rate skyrocketed at their store, right after the "First Steps" shelter was opened. For the following reasons I urge the City Council not to approve the proposed homeless shelter.

Funding has a limited time for acceptance which does not allow for careful impact review.

As stated at the August 3rd work session housing will be limited to adults only. Which leaves no provision for parent/child needs.

Facility will consist of 21 units with a projected stay of six to nine months per resident. This does not seem to support the claim it will have a major impact on the homeless population here in Florence since the official homeless count is 347 and growing.

It was also claimed the facility located North of town would keep the homeless out of the tourist areas. With only 21 units this is not true just check the bus stops on any given day.

At the August 3rd work session, it was stated staffing would be from Florence area but as reported in the Siuslaw News the management and staffing of the Florence facility will be controlled by the Devereux Center based in Coos Bay.

It was also claimed they did not anticipate any increase in the homeless population from outside the area. This is wishful thinking. Perception becomes a person's reality and as reported by Bob Teter of Siuslaw Outreach Services Coos and Lincoln counties are bussing homeless into our area as they believe SOS has more capability to handle the homeless population. It is reasonable to believe when the word gets out "Florence has a new Homeless Shelter" there will be an influx of homeless folks.

I have lived in the Florence area for over 34 years. I have seen our community recover from a dying timber and fishing economy and grow into a strong tourist and retirement economy. I agree we need to deal with the homeless problem but this is not the answer. Act in hast and regret at leisure.

- B. THE "TRAVELERS" ARE PASSING THROUGH. PEOPLE WHO ARE LOCAL AND IN NEED...DO NOT NEED A PROGRAM LIKE THIS...THEY NEED LOCAL EMPLOYMENT AND SUBSIDIZED HOUSING/UTILITIES/FOOD. THIS IS NOT A GET OUT OF POVERTY PROGRAM.
- C. I WAS THE MASTER OF THE MASONIC LODGE WHEN WE STARTED THE COLD WEATHER PROGRAM 8 YEARS AGO. EVERYONE WHO IS A BLEEDING HEART WANTS TO PREACH HOW MUCH THEY CARE, BUT AT MIDNIGHT WHEN THERE IS A PROBLEM...I WAS THERE ALONE. THEY WERE AT THIER' GATED COMMUNITIES WITH WHITE WINE. This is in regard to our opposition to the proposed emergency shelter in Florence.

Our concerns are:

- 1. We strongly agree with the concern of bring more homeless into Florence increasing impacts on our properties, businesses, tourism and health issues associated with hygiene garbage. This would not be solved by 30 beds with an influx of perhaps hundreds.
- 2. When the funds run out in 2025 where does the burden fall but to the people and tax payers of Florence, not Eugene who have their own problems with this issue. It was also stated that Florence's shelter would benefit from possible funds from Lane County. It is good to hope the funds will be found but if not the large population of retirees in Florence will feel the impact.
- 3. If the shelter is actually to help individuals become a productive part of society will they need to find work and become independent or just have a safe place to live without responsibilities? There are businesses constantly looking for help even in our small community.
- 4. Would not these funds better serve the mentally disabled and drug addiction programs?
- 5. Who actually screens prospective inhabitants? To the questions they asked individuals in the article, all answered in a positive response, why would anyone answer in negatively? Is there a probation time? How can you do a background check on someone with no address or identification? The police are very helpful and appreciated by us but have little or no information on individuals coming from other areas. I understand the local residents and older people would have priority but the safety issues still exist.
- 6. We strongly disagree with the statement that the majority of homeless do not choose to be. This may be true of the FECWS people that were interviewed but again it is in their best interest to respond positively. The mentally ill need professional help not just a warm bed and if this is a large part of the homeless population as we have heard in the past, let us address that problem in a correct manner.
- 7. It is our opinion that those who choose to be homeless have no responsibilities, have many programs for food, have no regard for other's property or health concerns related to their living conditions. This is their choice but those of us who worked hard most of our lives and take pride in ourselves and home do not choose to live with these conditions.
- 8. Why should our neighbors and businesses be responsible for disposal of garbage, biohazards and other debris left by this population? This is not an isolated incident as we have seen evidence of this throughout the state, even parts of Salem are unapproachable due to the garbage and stench. This is a financial hardship on the community as a whole and our businesses who rely largely on tourism. I would not come here as a traveler if these conditions were prevalent and the influx of this population would increase with free shelters.
- 9. In the article it is stated by Tara Johnson that there is nothing that says they couldn't have a contract with PeaceHealth so someone would not be discharged to the street. Why is this not already addressed and given priority to help these individuals who obviously need help over someone who walks in and wants to stay. This is an acute concern, not one that can be estimated ahead of time.

We do feel compassion for the people who need help but providing a facility with no real plans for the future but resting on hope is not the answer. Fund existing programs for those who need real help expanding those facilities and staff makes more sense. There are a large number looking for a free handout as that population continues to grow when work is available to those who want it. As far as a residence requirement is needed, how is it that so many of these individuals have cigarettes, cell phones and animals? This is not the minority of homeless.

Dear Mayor Ward and Esteemed Councilors:

As a Florence resident, long-time member of various iterations of the Florence Community and Economic Development Committee, and chair of the City's recent Housing Implementation Plan Stakeholders Advisory Team (HIPSAT) that brought together a diverse, remarkable group of residents, consultants, and subject matter experts to consider codebased steps toward long-term solutions to persistent housing issues, I want to thank you for your care and diligence as you consider the FECWS proposal for an emergency shelter.

You will know that the HIPSAT formed three workgroups to delve deeper into especially complex topics, including one focused on transitional housing. As described in the work session on August 3, the proposal for a permanent emergency shelter is an adjacent topic, and the seeds for code-based guidance may be found in the HIPSAT work product.

I am a fan, a former board member (and board chair) of the Florence Area Chamber of Commerce, and I appreciate their recent effort to encourage thoughtful consideration, to "look before we leap" into the thorny problem of homelessness that has dashed many good intentions in cities throughout Oregon. At the same time, I am sensitive to the plight of many houseless people in our community and aware that this extra funding available to launch a program to help has a definite expiration date.

Therefore, I suggest you consider forming a short-term team (and you might do well to start with the HIPSAT's Transitional Housing workgroup) to provide you with a clear-eyed report outlining the possibilities and pitfalls before the deadline for this funding stream so you can make an informed decision. A long "economic impact study" will mean we miss out on this funding opportunity by default. We have the tools, the team, and just enough time to do better, and thread the needle between our common concerns and compassionate hearts.

Subject: Written Comments for tonight's City Council Special Meeting

The following are my comments regarding the homeless encampment City Council is considering at their meeting on August 14, 2023:

- 1. Security for the homeless encampment should be provided by the homeless people sheltering there. Each adult individual or one adult from each family unit shall serve as unarmed security with radios to communicate with the paid staff member on duty.2.
- 2. There should be a firm rule of no drugs or alcohol consumed while staying at the encampment. Being drunk or under the influence of drugs or drugs or alcohol found in the resident's quarters would be grounds for immediate eviction.
- 3. Each individual or each family should have their own lockable quarters, which would include a lock inside for security while sleeping and a lock on the outside for security of belongings when resident is not in their quarters.
- 4. No money should be spent on a van to transport residents. Homeless people are used to walking and there is a local public bus service in Florence. This grant money should be used very frugally to improve the encampment.
- 5. Agree the homeless encampment should be fenced. There should be land outside the fence reserved for off street parking for the paid staff member and some homeless resident cars.
- 6. Porta potties and outside hand washing stations should be used for restrooms. ADA porta potties do exist. There exist portable trailers with multiple individual shower stalls/dressing cubicles. One should be purchased or leased for this encampment. Leases should include maintenance.
- 7. The quarters should be military tents on a waterproof foundation; I am sure very sturdy ones are available from military supplier companies. Stick built structures are too expensive for a place to sleep and keep the individual's belongings secure.
- 8. One modular or trailer kitchen for group or individual cooking could work, with picnic tables for eating in a separate large tent. The cleanup of the kitchen trailer and the eating tent would be done by the residents on a rotating basis.
- 9. To save money, there should only be one paid staff member on duty for a nine hour shift, 3 shifts a day with the one hour overlap, for communication between shifts.

Notes to the City Councilors: I got the first three ideas above from a documentary about a successful homeless camp in a big city, which remained so safe that families with children were comfortable there. No alcohol and no drugs will be critical: those who wish to continue with their addictions can go fend for themselves.
