- Using a formula to calculate an acceptable amount for each fund during the budget process.
- Desired Building Fund reserve is a 60-day reserve which fluctuates from biennium to biennium.
- Florence Events Center is self-supporting.
- Depending on how you look at the funding, it could be considered underfunded if there were a lot of projects that were needed to be done and the funds were not there to do the projects. Airport and Streets do not spend anything they do not have.
- What is taken in at the airport in the form of leases does not cover the maintenance of the runways. Public Works is able to obtain grants to pay for those items.
- Forecasting into the future as preparations are made for the biennial budget, we will be talking about that subject of underfunding.

- Councilor Wantz Was this designed as an incentive to build or make housing more affordable? Needing additional information before considering. CM Reynolds System Development Charges are restricted and regulated by State law. Funds are only to be used for capacity increase projects related to the utility that it was collected for. We do not have a Parks SDC. We would not allow any collected System Development Charges to be used for something else. PWD Miller Defining increasing capacity such as sewer. Using Driftwood Shores as an example, when sewer was extended to Driftwood Shores, there was ample coverage for the entire area.
- Mayor Ward Has this program accomplished what it was supposed to accomplish?
- Councilor Beaudreau This is a really good tool to access more affordable housing in this marketplace. Would like to discuss shifting exemption percentage to encourage smaller housing. Wanting to know more about economic factors. CM Reynolds There is no scientific modeling to share what works for increasing more affordable housing. The number one suggestion to incentivize housing is the SDC discount.
- ➤ Councilor Meyer When adopting the discount based on dwelling size, it was an incentive to construct houses that are more affordable. It looks like the incentive is there. My position at this point is to continue the program.
- Councilor Wantz Is Florence a friendly place to build? PWD Miller -Florence does not have a true developer in town. Understanding how development happens with developers.
- ➤ Councilor Wantz If we can be inviting to contractors or homebuilders and we can help them out with a discount, I am okay with that.
- ➤ Councilor Carp This Council and previous Councils have done a tremendous job with increasing housing. Now we need to focus on finances and what the City needs financially. All costs are increasing including employee and material costs. My position is to stay financially strong. I am opposed to extending this Ordinance.
- Mayor Ward Having mixed emotions about this issue.

- > Councilor Meyer Does this encourage building houses larger than 1800 square feet? CM Reynolds SDC fees are a flat fee. The purpose was to encourage building work force housing.
- ➤ Mayor Ward Due to the fact starter homes start at \$400,000, the apartments that are being built are incredibly important. If we are going to give discounts, that is what we need to focus on.
- ➤ Councilor Beaudreau It is important to have a variety of stock of houses available to people. It is important having different types of housing for people in their different stages of life. I don't think apartments are the only answer. It is a multi-faceted issue.
- > Mayor Ward I wasn't implying apartments are the only answer. I only mentioned apartments because they are severely lacking.
