DLCD Technical Assistance Grant Application







Resolution No. 18, Series 2025

Consider approval of Resolution No. 18, Series 2025, a resolution authorizing application for, and acceptance and administration of, the Oregon Department of Lane Conservation and Development (DLCD) 2025-2027 Technical Assistance (TA) Grant for the 9th Street Planning Area Comprehensive Plan, Zoning, and Transportation System Plan Amendments.

What & Why (DLCD TA Grant: 9th St. PO/I Update)

Ask: Authorize staff to apply for DLCD's 2025–27 Technical Assistance (TA) grant to modernize the West 9th St. Area Comprehensive Plan, zoning, and and related TSP elements.

Why now: Legacy PO/I policies still govern despite the City's updated wetland & riparian inventories—inventories—creating over-regulation in unconstrained areas and under-protection where it's needed most. Recent Elm Park transportation work also revealed the need to refine TSP concept routes through sensitive areas.

Grant window: Single application round; deadline October 10, 2025.

Delivery models (either acceptable):

- DLCD-provided consultant (state-managed; services value estimated \$150k-\$200k; no cash to City).
- Direct Grant (City-managed consultant; staff would return with NTE amount and budget adjustments if if awarded).

Scopes & Products

Scope & Products:

- Equity-centered engagement plan with measurable participation targets.
- Issues & Options memo and alternatives matrix (overlay/rezones/form standards) tied to adopted Goal 5 inventories.
- Comprehensive Plan & Zoning text/map amendments for the 9th St. area.
- TSP text/map amendments + Transportation Planning Rule "significant effect" findings.
- Hearing-ready staff reports, findings, ordinances/resolutions, and DLCD notices (ORS 197.610/.615).

Costs & Action

Fiscal/Capacity: No hard local match; staff time provided in-kind. If Direct Grant is awarded, staff returns with NTE, any local contribution cap, and procurement steps.

Alignment with Council Goals: Streamlines service delivery, protects resources, supports economic development, focuses capital planning on feasible corridors, and commits to transparent, inclusive engagement.

Requested Action (Tonight): Adopt Resolution No. 18, Series 2025 authorizing application under either delivery model and authorizing the City Manager to execute related documents.

Alternatives:

- 1. Adopt the Resolution authorizing staff to apply to DLCD's 2025–27 TA program, allowing either Direct Grant or DLCD-Provided Consultant models.
- 2. Adopt with modifications.
- 3. Do not adopt; provide directions to staff.

Recommendation:

Staff recommends the City Council adopt Resolution No. 18, Series 2025 authorizing staff to apply for DLCD's 2025–27 Technical Assistance (TA) program to complete adoption-ready Comprehensive Plan, zoning, and TSP amendments for the 9th Street Planning Area; authorize the City Manager to execute all related documents and take actions necessary to implement an award, including consultant procurement if a Direct Grant is awarded.

RIVER OTTER - My creature for today exists in our own back yard



In December of 2024, a family of river otters was spotted in the Siuslaw River in Old Town. River otters are a bellwether of the health of our river estuary. Their presence indicates good things about our river.

However, the river otter is susceptible to the effects of climate change. As sea levels rise the waters will become too brackish for them since they are primarily fresh water animals. When more frequent storms hit our region many of their burrows will disappear. Their plight is not the same for the sea otter, a

different species. They became extinct on the Oregon Coast in 1906 from over hunting. Today sea otters in the Pacific Northwest are suffering from the acidification of the ocean due to climate change.

Now I move to my subject for today, the state of climate action plans within the Oregon Coast tourism industry'

I thank the Travel Lane County for presenting at the City Council meeting. Although they have not adopted a standalone climate action plan for its operations, Travel Lane is developing a 10-year **Destination Master Plan** that includes a sustainable tourism framework, one that seeks to balance economic growth with community values and environmental protection. 



01 Develop a 'Climate Action Plan'

Adopted by your executive board within 12 months of your initial declaration, or sooner if possible.

02 Share your commitment and progress publicly

Share your initial public declaration, your 'Climate Action Plan', and update on progress against your targets each year.

03 Cut carbon emissions

Accept current IPC advice stating the need to cut global emissions to 55% below 2017 levels by 2030 to keep the planet within 1.5 degrees of warming. Ensure your 'Climate Action Plan' represents actions designed to achieve this as a minium, through delivering transparent, measurable and increasing reductions in the total carbon emissions per trip arising from your operations and the travel services sold by you.*

04 Work together

Encourage suppliers and partners to make the same declaration; share best practice amongst peers: and actively participate in the Tourism Declares community.

05 Advocate for change

Recognize the need for system change across the industry to accelearte a just transition towards carbon-free tourism


