

**CITY OF FLORENCE
ORDINANCE NO. 23, SERIES 2021**

**AN ORDINANCE AMENDING FLORENCE CITY CODE (FCC) TITLE 2, CHAPTER 1,
SECTION 4-E REGARDING SERVICE YEAR TERMS FOR STANDING
COMMISSIONS AND COMMITTEES**

RECITALS:

1. Florence City Code (FCC) Title 2, Chapter 1, Section 4-E establishes the general provisions that govern the City's standing committees and commissions. These standing committees and commissions serve the City by aiding the City Council in the conduct of public affairs.
2. Currently, FCC 2-1-4-E establishes a committee service year that runs from February 1 through the following January 31.
3. To better match with ongoing City business and the development of work plans for the City's standing committees and commissions, the City Council wishes to adjust the service year to instead run from June 1 through the following May 31.
4. The intent of the City Council with this amendment is to extend the current 2021-2022 service year through May 31, 2022, after which the new twelve-month service year will apply.

Based on these findings,

THE CITY COUNCIL OF THE CITY OF FLORENCE ORDAINS AS FOLLOWS:

1. Florence City Code Title 2, Chapter 1, Section 4-E is amended as shown in Exhibit A, in full, to read:
 - E. TERMS:** The term of office for each commission and committee shall be established in its enabling provisions and shall run on a committee service year from June 1 to the following May 31. Initial terms for a newly created commission or committee shall be staggered so that the majority of the positions do not become vacant in the same year and so that an equal or approximately equal number of positions become vacant each year.
2. Except as amended above and as shown in Exhibit A, FCC 2-1-4 remains unchanged.
3. In accordance with the Florence Charter, this ordinance will take effect 30 days after adoption.





CHAPTER 1 COMMISSIONS & COMMITTEES - GENERAL PROVISIONS

2-1-4-E: TERMS:

TERMS: The term of office for each commission and committee shall be established in its enabling provisions and shall run on a committee service year from ~~February 1st to the following January 31st~~ June 1 to the following May 31. Initial terms for a newly created commission or committee shall be staggered so that the majority of the positions do not become vacant in the same year and so that an equal or approximately equal number of positions become vacant each year.
