# Ordinance No. 1, Series 2024 – Housing Code Updates Written Record Open through February 15, 2024 at 4 pm

**FLORENCE, OR** – On Monday, February 5<sup>th</sup>, the City Council reviewed Ordinance No. 1, Series 2024 at their regular City Council meeting. At the February 5<sup>th</sup> meeting, the City Council received the staff report on the proposed ordinance, heard testimony during the public hearing, asked questions of staff, and discussed the process of the ordinance adoption. The City Council elected to close the public hearing, but hold the written record open as an opportunity for the public to have more time to review the proposed ordinance and background materials, as well as receive additional information related to the questions from Council asked at the meeting. The written record will be open through Thursday, February 15<sup>th</sup> at 4 pm.

#### About Ordinance No. 1, Series 2024

Ordinance No. 1, Series 2024, is an ordinance adopting legislative amendments to the Florence City Code Title 10, to support missions, emergency shelters, and transitional housing, associated with phase 2 of the Housing Implementation Plan project and reduce lot dimensions for medium density single unit detached dwellings.

This ordinance is the next step in the process of updating the City's housing codes that began in 2017. This ordinance addresses transitional and emergency housing, a portion of the initial Housing Implementation Plan (HIP) process that was delayed due to the need for additional time to develop the proposed code. The topic was included with the recent 2022-2023 HIP Phase 2 process.

House Bill 2916 (2019) implemented under ORS 446.265 directs jurisdictions to permit transitional housing which they define as "accommodations (that) are intended to be used by individuals or families on a limited basis for seasonal, emergency or transitional housing purposes and may include yurts, huts, cabins, fabric structures, tents and similar accommodations." The accommodations are limited to persons who lack permanent or safe shelter or cannot be placed in other low-income housing.

Proposed Ordinance No. 1, Series 2024, includes amending Florence City Code (FCC) Title 10 to permit Transitional Housing, Emergency Shelters, and Missions and creating code criteria. It also updates the Medium Density District to reduce lot frontage and lot size requirements. Transitional housing is defined in the proposed code as "residential shelter provided for an extended but definite period that is integrated with other social services and counseling programs to assist in the transition to self-sufficiency through the acquisition of permanent housing." The emergency shelter and mission criteria are intended for a

similar population as the transitional housing. They are not intended for natural disasters or similar. That sheltering will be considered for a code update to FCC Title 1 through a future proposed ordinance process.
