

**CITY OF FLORENCE  
ORDINANCE NO. 9, SERIES 2015**

**An Ordinance of the City of Florence, Lane County, Oregon Amending Florence  
City Code Title 2, Chapter 5 – Urban Renewal Agency of The City of Florence,  
clarifying the agency’s membership.**

RECITALS:

1. On May 27, 2015 the Florence Urban Renewal Agency (FURA) reviewed their bylaws and the Florence City Code to discuss the discrepancy in the number of members allotted to the board and requested the Florence City Council review the City Code concerning the FURA membership to clarify the number of board members.
2. The Florence City Council reviewed this request on June 15, 2015 and elected to amend Florence City Code Title 7, Chapter 5, to specify the number of members to the FURA board as nine.

Based on these findings,

THE CITY OF FLORENCE ORDAINS AS FOLLOWS:

1. The Florence City Code Chapter 7 of Title 5: Florence Urban Renewal Agency, is amended as shown in Exhibit A.
2. This Ordinance shall become effective 30 days after adoption.

TITLE 2  
CHAPTER 5

**URBAN RENEWAL AGENCY  
OF THE CITY OF FLORENCE**

**2-5-5: BOARD OF DIRECTORS:** The Board of Directors shall be made up of nine members who shall be appointed based upon their positions as follows:

- A. One shall be the Mayor of Florence.
- B. Two shall be City Councilors of the City of Florence.
- C. One shall be nominated by the Lane County Board of Commissioners.
- D. ~~Six~~ Five shall be citizens at large. Special consideration shall be given to the potential appointment of elected members of the governing bodies of the Western Lane Ambulance District, the Port of Siuslaw, Siuslaw Valley Fire and Rescue, and/or the Siuslaw Library District.
