PLANNING COMMISSION DISCUSSION ITEMS

RV parking

CP Muilenburg commented there are numerous RVs parked in parking lots within the City and noted that it seemed to be partly due to the lack of rental options after people have moved here for jobs. PD FarleyCampbell agreed it was a problem in the City and pointed out Goal 3, Objective 5 creating more opportunity for housing options. CP Muilenburg added there was an empty lot that could be utilized for parking.

Homelessness

C Bare expressed his concern over the growing problem of particularly homeless women and children, and PD FarleyCampbell reported that Council would be addressing this problem with added financial support for local non-profit organizations and she indicated there had been some interest in the past from local churches to develop a mission location. CP Muilenburg pointed out the stalled low-income housing project north of town.
