ITEM TITLE: Building Replacement Extension – 125 Highway 101 Dairy Queen

## **OVERVIEW:**

<u>Request:</u> Landon Development LLC is requesting an extension of the timeline to replace the Dairy Queen building at 125 Highway 101. On August 18, 2021 at approximately 1 a.m. a fire broke out in the restaurant. The building underwent inspection by the Fire Marshall and was later demolished.

There has been minor work since the issuance of the demo permit such as removing the building remnants in stages and extension of utilities south along Kingwood to Bay St. A pre-application meeting was held with the architect in October or November 2021. Application for land use review was received July 12, 2022 and payment on the 21<sup>st</sup>.

<u>Code:</u> Dairy Queen received land use approval in 1978 under file number 8 21 78-7 DRB. As one can imagine there are a number of design elements to the building and the site layout that are pre-existing non-conforming. <u>FCC 10-8-4</u> states a nonconforming building and structure may be replaced in accordance with the Building Codes and use which existing at the time of such damage or destruction. Replacement must be commenced within one year from the date of the destruction and diligently followed to completion. The Planning Commission, with a written request of the applicant, may extend the period an additional year. The one-year anniversary of the fire is August 18, 2022. August 19<sup>th</sup> the site will lose its pre-existing non-conforming status unless an extension is granted.

<u>Process:</u> Extension requests for buildings being replaced under FCC 10-8-4 are reviewed and decided by Planning Commission. There are no criteria and no process is specified in the code. The Planning Commission will deliberate and provide their final decision on this matter July 26, 2022.
