ITEM TITLE: Resolution PC 25 02 CUP 01 & PC 25 01 DR 01 – 1536 12th St. SOS

OVERVIEW:

<u>Application:</u> A request was received for approval of a Conditional Use Permit (CUP) and Design Review to allow for the Professional Offices use in an existing building situated in the High Density Residential District regulated by Florence City Code Title 10, Chapter 10. The project site is located at 1536 12th Street and previously housed a church. The applicant, Siuslaw Outreach Services, is requesting to use the site as a Professional Offices use, which is conditionally permitted in the High Density Residential District.

Request for Continuance: On June 2, 2025, the applicant submitted a written request to continue the public hearing to July 8, 2025. This request was made to allow additional time to revise materials, particularly related to the lighting and irrigation plans, following receipt of a photometric report that indicated the initial lighting proposal was inadequate. The applicant wishes to refine these submittals to ensure full code compliance and reduce the need for conditions or further clarifications during the public hearing.

RECOMMENDATION:	Open the hearing and continue to a time and date certain of July 8, 2025 at 5:30pm in the Council Chambers of the City of Florence.

Hi Bob,

Thanks so much for letting us know! Under Oregon Law (<u>ORS 227.178</u>), in order to extend the 120-day timeline of the application, we need a written request with a certain date. Currently, the absolute last date your application needs to be resolved by, including the resolution of all potential appeals, is August 16th, 2025. I would recommend requesting to extend that date by a round number, such as 30 or 60 days; the extension from the June 10th meeting to the July 8th meeting is 29 days, so I would just keep that in mind during your request.

Additionally, feel free to submit your updated materials whenever you'd like and I will start to work on that review and on updating my report to the Planning Commission. Best of luck finishing up those last few outstanding items!
