


Vicinity Map



Annexation Map



Referral Comments

- Lane County Transportation Planning:
 - oHeceta Beach Rd. classified as an Urban Major Collector.
 - oLC supports annexation.
 - Development to comply with Lane County road requirements.
 - No stormwater runoff to LC roads or drainage facilities.

Referral Comments

Public Works:

- <u>Sewer:</u> Distances to City sewer facilities in Hwy 101:
- Over ¼ mile to the East side of Hwy 101closest - requires directional boar under Hwy to gain access.
- o Over 1/2 mile to West side of Hwy 10.



Referral Comments

- Public Works Dept. Cont.:
 - Streets county and state ROWs no City jurisdictional maintenance.
 - Water provider Heceta Water People's Utility District will remain provider once annex is approved – (no connection at this time).

Consents

 Both Double and Triple Majority methods are met (100% of owners and 100% of electors consent to annexation).

Public Testimony

- Comments received from area property Resident as of 7/26/2021:
 - o Proposal not consistent with Comp Plan
 - Only benefits development, not orderly nor efficient use of land
 - City is taking advantage of legal loopholes that are unfair to Lane County resident and taxpayer

Public Testimony (Cont.)

 States City needs to stop relying on road maintenance subsidies from LC – City should assume full responsibility- "Do the right thing."

 See Findings of Fact for additional verbiage and staff responses.
