### **Reports and Discussion Items**:

Comm. John Murphey and Comm. Ron Miller announced that they will be stepping down from the Planning Commission as on January 1, 2023. Both are retiring. The Commission and Staff let them know that they will be missed.

#### **Directors Report:**

FarleyCampbell reported that on November 3<sup>rd</sup>, 2022 the Transportation Systems Plan update project will be officially launching with the public input portion. The stake holders group meeting will be 3:00 to 5:00 at the FEC and is open to the public. There will be extensive reading material available for this meeting. After the stakeholder's meeting at 5:30, there will be the TSP open house. This is a City project. All the information is on the City webpage. At the open house there will be stations setup with information available. The consultant has been doing a very regimented traffic impact study and needs information from others.

Comm. Murphey mentioned that there are quite a few intersections in town that need round-abouts.

Comm. Hauptman and Chair Young agreed.

Vice Chair A. Miller asked staff to update staff on upcoming meetings on the PC calendar.

FarleyCampbell said that she had more updates. Thursday, November 10, 2022, that there will be the Stake Holder Advisory Team meeting at 3:00-5:00. Also, on that date at 5:30, for the second open house for the Housing Implementation Plan, the consultant will be presenting the findings from the virtual open house. There were about 600 responses to the surveys. On December 5<sup>th</sup>, 2022, is the joint City Council and Planning Commission work session at 5:30. This will be to go over the proposed housing code updates.

Comm. Murphey asked staff if they would be sending reminders. FarleyCampbell said that they will be sending reminders.

## <u>Calendar:</u>

Next scheduled meeting is on November 8<sup>th</sup> for the item that was continued here tonight, and a request for annexation and rezoning for a property located south of the RV park at the corner of Heceta Beach Road and Rhododendron Dr., it is a property that has recently been cleared, it is in the County, and we don't have anything to say about clearing in the County. On November 11, 2022, staff thinks that Dairy Queen may be ready to be heard. Fairway Estates is also scheduled for that meeting, but believe they are going to waive their 120 days and reschedule for another date down the road because they are incomplete, They submitted a letter and forced completion; you will be hearing about them 11/22 if they don't waive their 120 days.

FarleyCampbell explained the 120 State law to process applications.

December 13<sup>th</sup> is a tentative meeting date – we do not have anything scheduled at this time.

On November 7<sup>th</sup> the City Council will be hearing a request for a mural for Linda Wilcox for the laundromat building on 37<sup>th</sup> Street.

Comm. Hauptman asked if there are any updates on Cannery Station.

FarleyCampbell said that there are no updates.

Comm. Hauptman asked if they need to apply for an extension, he mentioned that their sand screening is down and that it looks like an abandoned neglected piece of property and doesn't think this is a good look for Florence.

FarleyCampbell said that staff would check into what is happening with Cannery Station.
