

AGREEMENT FOR PUBLIC EXHIBITION OF ART

ARTIST / City of Florence, Oregon

Contract Summary

This agreement, made and entered into and effective upon the execution by and between the City of Florence, Oregon, a municipal corporation (referred to herein as "the City") and the artist named above (referred to herein as "Artist").

WHEREAS the City, through the "Art Exposed Rotating Outdoor Art Gallery" program of the Florence Public Arts Committee, has selected Artist's Sculpture named above (the "Sculpture") as part of the "Art Exposed" Exhibition; and

WHEREAS Artist has created and agreed to loan such sculpture to the City for public display for approximately two years during the "Art Exposed Rotating Outdoor Art Gallery" program,

Incorporating the above, the parties agree as follows:

- 1. By the Exhibit A Submission Deadline, if not already submitted, Artist shall submit to the City the information requested in Exhibit A, attached hereto and by this reference incorporated in this agreement.
- 2. The site of the installation of the Sculpture is **LOCATION** (**SPECIFIC** Street and Highway 101, Florence, Oregon) referred to herein as "the Site".
- 3. Artist agrees to transport and install the Sculpture, undamaged, at the Site by the Installation Date. Except as provided in #8 below, the Sculpture shall remain the property of Artist. However, by virtue of this agreement, the City is entitled to possession of the Sculpture, and Artist agrees to relinquish possession of the Sculpture, from the date of installation until the end of the Exhibition Period (shown above and detailed in #7).
- 4. After, but no later than the seventh day following, the end of the Exhibition Period, Artist agrees to remove the Sculpture from the Site, leaving the pedestal/base and all other aspects of the Site in the same condition as existed prior to installation of the Sculpture.
- 5. Transportation of the Sculpture to the Site, proper installation, proper de-installation, proper removal from the Site, and all associated costs and expenses, shall be the responsibility of Artist. By subsequent mutual agreement between the parties, the City may provide assistance with these activities. In order to minimize disruption of pedestrian and vehicular traffic, Artist agrees to schedule delivery and removal with the City, and to obtain all necessary permits associated with transportation, installation or removal, at least ten (10) days in advance.

Upon request, the City will assist Artist in identifying required City permits, obtaining necessary City application forms, etc. The City shall obtain any encroachment permits necessary to allow the Sculpture to be displayed at the Site.

- 6. During the Exhibition Period (date of installation through April 30, 2026), the City shall be responsible for reasonable maintenance of the Sculpture. By subsequent mutual agreement between the parties, Artist may assist the City with maintenance procedures. The City shall take reasonable steps to utilize the maintenance procedures designated by Artist in the approved concept. Artist waives any rights granted by 17 USC § 106A for reasonable maintenance undertaken by the City. Artist at Artist's expense shall provide any designated maintenance materials other than ordinary cleaning agents in the possession of the City. The City reserves the right to decline to implement any or all of the designated maintenance procedures if circumstances, including but not limited to cost, render implementation unreasonable. In the event the City declines to implement such procedures, Artist may, with the City's prior written approval, undertake such procedures at Artist's expense or the Artist may terminate the agreement at the Artist's option.
- 7. The Exhibition Period may be shortened or extended by mutual written agreement between the parties.

 Notwithstanding the foregoing or anything to the contrary in this agreement, the City reserves the right, with or without cause, to decline or terminate exhibition of the Sculpture at any time.
- 8. Artist agrees to offer the Sculpture for sale during the Exhibition Period at the current market price, subject to the obligation to the City of a "gallery fee" in the amount of 30% of the sale price, and, if so sold, may assign their right under this agreement to remove the Sculpture. If the Sculpture is sold, Artist will be provided the opportunity to replace the sold Sculpture with another of Artist's works upon the agreement and acceptance of the City through its Public Arts Committee and installation of the replacement sculpture concurrent with the removal of the Sculpture. If Artist is unable to replace the Sculpture within a time frame agreeable to both parties, then the Site will be made available to other artists. Under no circumstances shall the sale of the Sculpture terminate this agreement or adversely affect the City's rights hereunder, including, but not limited to the City's right of possession during the Exhibition Period. Artist agrees to promptly provide the City written notice of any sale of the Sculpture, including designation of the party to whom the sculpture should be released upon expiration or other termination of the Exhibition Period, and shall provide a copy of the sale agreement to confirm the identity of the party to whom the Sculpture is released, and shall either tender then or arrange for tender at the time of removal the above "gallery fee".
- 9. Artist hereby grants the City, in perpetuity, the right to photograph, film, videotape, or otherwise to record or depict the Sculpture at any time during the Exhibition Period and to use such photographs, films, videotapes, records or depictions at any time thereafter for the purpose of promotion of the "Art Exposed Rotating Outdoor Art Gallery" program, or of the City, provided that the City gives artistic credit to Artist concurrently with such use.
- 10. The City shall pay Artist an honorarium in the amount stated above for exhibition of the Sculpture, payable following installation of the Sculpture at the Site pursuant to #3 above. There shall be no obligation to make the payment if this agreement is cancelled or otherwise terminated for any reason prior to completion of the installation.
- 11. In the event of:

- Damage to the Sculpture during the Exhibition Period, from whatever cause, and the City reasonably deems the Sculpture to be a danger to the public health or safety, or
- The Sculpture is defaced by graffiti (as defined in ORS 164.381),

The City may give notice (written, email, or telephonic) to Artist that the Sculpture must be removed or protected within 5 calendar days of the receipt of the notice, in order to eliminate the risk of injury or death to the public, or to remove the graffiti. During that 5-day period, the City may take such action as deemed appropriate to temporarily protect the public from risk of injury or, if the Sculpture was defaced, to obscure the Sculpture in order to protect the surrounding area from the negative effects of graffiti. Artist waives any rights granted by 17 USC § 106A for reasonable actions undertaken by the City under this paragraph 11.

If Artist does not:

- Remove or otherwise secure the damaged Sculpture so it no longer presents a danger to the public health or safety, or,
- If the Sculpture was defaced, remove the graffiti,

within the 5-calendar day period, the City, at its discretion may:

- a) Cause the Sculpture to be removed from display and stored on City property that is reasonably secure, e.g. maintenance storage area, at the City's expense (subject to claim for reimbursement under the insurance policy provided by #12);
- b) Secure the Sculpture so it is no longer a threat to public health or safety or, if defaced, to remove the graffiti from the Sculpture, at the City's expense (subject to claim for reimbursement under the insurance policy provided in #12); or
- c) Terminate this agreement pursuant to #14 below:

Artist shall be deemed to have consented to the City's actions (a) and (b) above. Except to the extent damage to the Sculpture is covered under the insurance policy provided below, the City shall have no additional liability for damage or destruction that may occur during removal or protection of the Sculpture.

- 12. The City shall insure the Sculpture against damage or loss in an amount set forth in Exhibit A. Such amount is Artist's estimate of fair market value and does not bind the City or City's insurer to later dispute the claimed fair market value. The City's obligation to provide insurance is solely for the duration of the Exhibition Period and only while the Sculpture is located at the Site, excluding installation and removal. The City shall have no liability for damage or destruction that may occur during transportation to or from the Site, during installation, or during removal.
- 13. Artist agrees to indemnify and hold the City harmless from any and all claims, losses, damages, injuries, or liabilities of any kind whatsoever, including reasonable attorney's fees and costs, arising out of or related to the transportation, installation or removal of the Sculpture, or arising out of or related to any defects of the Sculpture, faulty workmanship of Artist or any acts of negligence by Artist, Artist's agents, or Artist's employees.
- 14. This agreement may be terminated at any time by mutual written consent of the parties. In addition, the City may terminate this agreement at any time upon the occurrence of any of the following events:
 - a. The City fails to receive funding, appropriations, or other expenditure authority at sufficient levels to make the payments provided for in this agreement.
 - b. Federal or state laws, regulations, or guidelines are modified or interpreted in such a way that the City is prohibited from proceeding under the terms of this agreement;

- c. Artist commits any material breach or default of any covenant or obligation under this agreement; or
- d. The Sculpture is damaged or defaced and the City elects to have the Sculpture removed from display, as described in #11 above.
- 15. Except for assignment to a purchaser of the right to remove the Sculpture after the Exhibition Period as provided in #8 above, this agreement is not assignable by Artist, either in whole or in part, without the prior written consent of the City. The City and Artist are the only parties to this agreement and are the only parties entitled to enforce its terms. Nothing in this agreement gives, or is intended to give, or shall be construed to give or provide any enforceable benefit or right, whether directly, indirectly or otherwise, to third persons.
- 16. The failure of the City to enforce any provision of this agreement shall not constitute a waiver by the City of that or any other provision.
- 17. This agreement represents the entire and integrated agreement between the City and Artist on the subjects addressed in this agreement, and supersedes all prior negotiations, representations or agreements either written or oral. This agreement may be amended only by written instrument signed by both Artist and the City.





ART EXPOSED REVISION FLORENCE - INTRODUCTION

The City of Florence Public Arts Committee's foundational project is the Art Exposed Rotating Outdoor Art Gallery, https://bit.ly/FlorenceArtExposed.

Art Exposed offers the community a chance to view interesting, fresh artwork every two years at a low cost, while providing artists with an opportunity to display and sell their work to a wide audience. Since 2018, this program has installed public art throughout Historic Old Town Florence.

Now, we are expanding up to Highway 101 with Art Exposed ReVision Florence.

Discussion

In the adopted 2023-2025 FURA Biennial Budget, the Urban Renewal Agency approved the placement of up to six pieces of art through City of Florence Public Art Program's Art



Exposed Rotating Outdoor Art Gallery. These artworks will be placed throughout the ReVision Florence corridor on Highway 101. This project has been named Art Exposed ReVision Florence, and will install artwork in April 2024 and decommission works in 2026.

The City of Florence Public Art Program's Art Exposed Rotating Outdoor Art Gallery is a dynamic bi-annual rotation of public art that enhances the livability of our community, creates a unique sense of place, and enhances community identity, while also providing an increased economic impact for visitors and residents. Art Exposed offers the community a chance to view interesting, "fresh" artwork every two years at a low cost, while providing artists with an opportunity to display and sell their work to a wide audience.

The City of Florence Public Art Program currently has eight locations showcasing art in Historic Old Town: Veterans Memorial Park, River Roasters, Rain Garden, Interpretive Center East, Gazebo Park Plaza, Gazebo Park Planter/Secret Garden, Maple Street Park, and the Florence Area Chamber of Commerce Lawn. These locations are maintained by Florence Public Works crews and overseen by the Florence Public Arts Committee. Now, with funding by FURA, six more sites will be installed.

The Florence Public Arts Committee held an in-depth discussion at their meeting on February 15, 2024, reviewing the applications submitted for the new round of artwork to be displayed. All materials for that meeting are available at https://www.ci.florence.or.us/bc-pac/public-arts-committee-meeting-17. During the discussion, the committee considered many factors for both the six new locations on Highway 101 and the 12 submitted sculptures.

Art Exposed ReVision Florence Selects Finalists

FLORENCE, OR – The City of Florence's Art Exposed Rotating Outdoor Art Gallery is a dynamic bi-annual rotation of public art that improves the livability of the Florence area, creates a unique sense of place, and enhances community identity, while also providing an increased economic impact for visitors and residents. The City of Florence Public Arts Program is excited to announce that additions to the Art Exposed Program will be coming soon, with the installation of up to six new pieces on Highway 101.

Art Exposed offers the community a chance to view interesting, fresh artwork every two years at a low cost, while providing artists with an opportunity to display and sell their work to a wide audience. Since 2018, this program has installed public art throughout Historic Old Town Florence. The 2024-2026 call expands the program up to Highway 101 through Art Exposed ReVision Florence.

The Florence Public Arts Committee held an in-depth discussion at their meeting on February 15, 2024, reviewing the applications submitted for the new round of artwork to be displayed. 




The Florence Art Committee will be selecting the finalists for each location during a public meeting on Thursday, Feb. 15, at 5:30 p.m. at Florence City Hall.



ART EXPOSED REVISION FLORENCE - PROCESS

- In the adopted 2023-2025 FURA Biennial Budget, the Urban Renewal Agency approved the placement of up to six pieces of art through City of Florence Public Art Program's Art Exposed Rotating Outdoor Art Gallery. These artworks will be placed throughout the ReVision Florence corridor on Highway 101.
- At your September 27, 2023, meeting, you directed Staff and the Florence Public Arts Committee to begin the process of operating Art Exposed ReVision Florence. This included:
 - Describing each location and the unique specification for a call-to-artists through Call for Entry (CaFÉ)
 - Marketing the call to local, regional, and state artists
 - Working in a subcommittee and then the greater committee to review the applications and eventually vote on finalists, all in public meetings
- City staff then notifies the artists and negotiate contracts and timelines for installation
 - Public Works, Community Development, Administration, and other City staff are part of the process
