**Note:** Written comments received at least 2 hours prior to the meeting will be distributed to the Committee, posted to the City of Florence website, and made part of the record.

- Verbal Testimony:** Citizens wishing to express their views to the Committee may participate in the meeting in-person or via GoToWebinar. To do so, please complete a speaker's card online at <https://www.ci.florence.or.us/bc-pac/public-arts-committee-speakers-card> at least 1 hour prior to the meeting. City staff will then contact the speaker to let them know the process to participate in the meeting.
  - Public Comments on items not on the agenda: General public comments (on items not on the agenda) will be allowed at each Committee meeting during the public comment agenda item. Comments will be limited to three (3) minutes per person, with a maximum of 15 minutes for all items. In practicality, this means no more than five individuals will be allowed to comment verbally. There is no limit on written public comments.
  - Public Comments on Action Items: Public Comments will be allowed on each action item on the Committee agenda. Verbal comments will be allowed on action items after staff has given their report and have allowed time for initial Committee questions. Comments will be limited to three (3) minutes per person, with a maximum of 15 minutes for all comments on each action item. In practicality, this means no more than five (5) individuals will be allowed to comment verbally. There is no limit on written public comments.

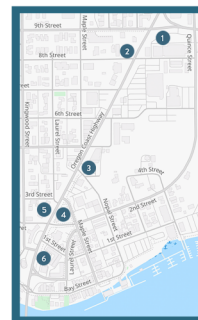
As soon as those items are done, we will then engage in a meet-and-greet with our artists. There will be light snacks available.

## **Art Exposed ReVision Florence Begins Installation**

**FLORENCE, OR** – The City of Florence’s Art Exposed Rotating Outdoor Art Gallery is installing six new pieces of art on Highway 101. Art Exposed is a dynamic bi-annual rotation of public art that improves the livability of the Florence area, creates a unique sense of place, and enhances community identity, while also providing an increased economic impact for visitors and residents. The City of Florence Public Arts Program is expanding the program from the Historic Old Town Area to Highway 101 through Art Exposed ReVision Florence, <https://bit.ly/FlorenceArtExposed>.

The Florence Public Arts Committee selected the finalists for Art Exposed ReVision Florence at their meeting on February 15, 2024. All materials for that meeting are available at <https://www.ci.florence.or.us/bc-pac/public-arts-committee-meeting-17>.

Congratulations and welcome to the selected artists and their works:

- Location #1 – Highway 126: Rick True, "Golden/Yellowstone"
- Location #2 – Eighth Street: Steve Tyree, "Cougar on the Run"
- Location #3 – Nopal Street: Susie Zeitner, "Sea Dreams"
- Location #4 – Maple Street: Harold Linke, "Encore"
- Location #5 – Laurel Street: Lin McJunkin, "Kelp Totem IV: Orca"
- Location #6 – First Street: Helena Chastel, "Denary"

Four of the artists come from Oregon, one resides in Washington, and one is from New York. Each of the pieces represent a variety of styles, designs, and types of sculptural artworks. All will be part of the ReVision Florence Streetscaping Corridor on Highway 101 for the next two years.

Installation of Art Exposed ReVision Florence will begin in May 2024. This summer, look for news on a Walking Tour of the six new sites of Art Exposed.

Art Exposed offers the community a chance to view interesting, fresh artwork every two years at a low cost, while providing artists with an opportunity to display and sell their work to a wide audience.
