Hello again Roxanne – I see (in your email below) that the City of Florence Transportation Committee is also inquiring about ODOT's plan to address the flooding on OR 126 in the Cushman area.

Here's what I know. ODOT recently repaired a stormwater drainage system that was not function properly. This will alleviate some of the flooding in this area.

A more comprehensive solution will require elevating the railroad that crosses over the highway. This will enable ODOT to elevate the roadway, to eliminate the low spot that is vulnerable to flooding. This would be very expensive. The estimated cost is \$5M. This project is not currently funded. It could be many more years before it is funded.
