# FLORENCE URBAN RENEWAL AGENCY RESOLUTION NO. 1, SERIES 2018

A Resolution adopting a minor amendment to the Florence Downtown Preservation and Renewal Plan, authorizing acquisition of the Old Middle School Property.

## **RECITALS:**

- 1. The Urban Renewal Agency of the City of Florence, commonly known as the Florence Urban Renewal Agency (FURA), has the authority to implement the Florence Downtown Preservation and Renewal Plan.
- 2. The property acquisition was formerly occupied by the Siuslaw School District middle school and is within the boundaries of the Florence Downtown Preservation and Renewal Plan (Agency Plan).
- 3. The Middle School property is located on the east side of Quince Street and south of 8<sup>th</sup> Street. The property is made up of tax lots:
  - a. 18-12-26-33-00900 approximately 7.06 acres and 18-12-26-33-00901.
  - b. 18-12-26-33-00901 approximately 6.33 acres.
  - c. Total acreage for both tax lots is approximately 13.39 acres.
  - d. The eastern property border is the Siuslaw River estuary.
- 4. The Agency plan calls out the old middle school property as a possible development site worthy of Agency focus. Section 700C of the Agency plan describes how the Agency can get involved in redeveloping properties within the plan area and specifically lists the old middle school site among the properties subject to potential Agency redevelopment assistance.
- 5. The old middle school property is currently owned by Aspen Flo LLC. Aspen Flo LLC purchased the property from the Siuslaw School District in 2005. Since 2005, Aspen Flo has tried to sell the property. After unsuccessfully trying to sell the property via auction, Aspen Flo LLC approached the City of Florence to see if it had an interest in purchasing the property.
- 6. Aspen Flo wishes to convey the old middle school property and is offering the property to the Agency at a price that is well below the property's recent listing price.
- 7. Agency Plan Section 1100C defines the minor amendment process and states that a minor amendment is used for the acquisition of property for the purposes set out in Agency Plan Sections 800B1 and 800B2. Agency plan section 800B2 describes land acquisition when "the owner of real property within the boundaries of the area wishes to convey title of such property by any means, including by gift". Agency Plan Section 1100C applies to the Agency Plan amendment proposed here.

Based on these findings,

# THE BOARD OF DIRECTORS OF THE URBAN RENEWAL AGENCY OF THE CITY OF FLORENCE RESOLVES AS FOLLOWS:

- 1. A new paragraph is added to Agency Plan Section 800C as follows:
  - a. By plan amendment in April, 2018, the old middle school property is identified for acquisition. The old middle school property is known as tax lots 18-12-26-33-00900 and 18-12-26-33-00901, totals approximately 13.39 acres, and is shown on the map attached to the Plan as Exhibit 2.
- 2. A new Exhibit 2 is added to Part 2 of the Agency Plan. The new exhibit is attached and incorporated herein.
- 3. With this Agency Plan amendment, expenditure of Agency funds to acquire the old middle school property is authorized.
- 4. This Resolution shall take effect upon passage by the Agency Board of Directors.
