- 2. <u>Verbal Testimony:</u> Citizens may provide verbal comments at the meeting via the GotoWebinar platform. To do so, please complete a speaker's card at least 1 hour prior to the start of the meeting (October 29, 2020 at 4:00 p.m.).
